# STAFF RECOMMENDATION AND BASIS FOR APPROVAL

### STAFF REPORT

### I. GENERAL INFORMATION

The Commission shall annually review all property zoned to the S-O study overlay district and shall file a report and recommendation with the city council on the need to continue the zoning and the appropriateness of rezoning the property or any part thereof to another zoning classification.

The Corps of Engineers conducted open house meetings in the Spring of 2005 to present their preliminary findings and recommendations for the Four Mile Creek watershed. At this time the recommendation that has been forwarded to the U. S. Congress does not suggest development of any major designed flood control improvements for further protection of property near the flood fringes. It was anticipated that these findings would have Congressional approval some time late Fall 2005. To date the U.S. Congress has not accepted these preliminary findings. At such time that they are accepted by U.S. Congress, the specific data will be brought back to the Plan and Zoning Commission for further direction on recommendations for changes to the zoning. The Plan and Zoning Commission does have the flexibility of making recommendations to the City Council in the interim without having to wait for the annual review.

Until the final Corps study is adopted, staff believes that continuation of the protection provided by the "S-O" District is the most appropriate action to take. Should this ultimately be the decision made by the Council, it would be appropriate to send written notification to affected property owners to advise them of such a determination and update them on the current status of their property.
