At their meeting on July 24, 2006 the Des Moines City Council voted to suspend the allocation of \$75,000 of 2006 HUD Community Development Block Grant (CDBG) funds for the CIETC – Project Employment Program.

These funds were allocated at the City Council meeting on November 21, 2005 as part of the City's Second Action Year of the 5-year HUD Consolidated Plan for the contract period from January 1, 2006 to December 31, 2006.

This action was taken based on recent disclosures regarding CIETC's lack of capacity to properly administer publicly funded programs.

Part of the Council's action on July 24, was to establish a number of conditions upon the satisfactory resolution of which, could result in the release of the CDBG funds to either CIETC or an eligible successor agency.

These conditions include the following:

- Approval by the CIETC Board of Directors of a new management structure.
- Approval by the CIETC Board of management protocols (administrative guidelines), which will ensure the proper management of public funds.
- A review of the findings of the outstanding investigations in so far as they impact the ongoing operations of the CIETC Board.
- The repayment of any CDBG funds found by the investigations to be ineligible expenditures under previous contracts with the City.

All of the above conditions would have to be met before the City Council would consider reinstating the CDBG funding. In addition, all contract requirements regarding the documentation of eligible costs and program operations would have to be submitted to the City for review before any PY 2006 expenses could be reimbursed. We suggest that the agency use the 2005 contract as a guide to the requirements for reimbursement.
