APPROVING EXECUTION OF A COOPERATIVE AGREEMENT BETWEEN THE CITY OF DES MOINES, IOWA, AND THE UNITED STATES DEPARTMENT OF HOUSING AND URBAN DEVELOPMENT (HUD)

WHEREAS, on September 8, 1987, the City Council of the City of Des Moines, by Roll Call No. 87-3813, authorized the Des Moines Human Rights Commission to execute a Memorandum of Understanding between the City of Des Moines Human Rights Commission and HUD setting forth the terms and conditions by which the Commission processes housing discrimination complaints arising within the corporate city limits of Des Moines, Iowa, in accordance with HUD's Fair Housing Assistance Program, and sends staff to mandatory training as required by HUD; and

WHEREAS, the City Council has approved similar agreements on an annual basis; and

WHEREAS, this Cooperative Agreement provides \$25,008.00 in payment for investigations of housing discrimination complaints arising within Des Moines, Iowa which were completed in FY2005, and for administrative costs; and

WHEREAS, this Agreement must be returned to HUD following its approval by the City Council.

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Des Moines, Iowa, that the Cooperative Agreement between the United States Department of Housing and Urban Development (HUD) and the City of Des Moines is hereby approved, and the Mayor is hereby authorized and directed to execute the Cooperative Agreement on behalf of the City of Des Moines.

BE IT FURTHER RESOLVED that the Des Moines Human Rights Commission's Interim Director is hereby authorized and directed to submit the Cooperative Agreement to the HUD office and to complete and submit any additional documents associated therewith.
