BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF DES MOINES, IOWA: That the contract and bond, in the amount of \$609,553.78, executed by Des Moines Asphalt & Paving Co., Jim Gauger, President, P.O. Box 3365, 5550 NE 22nd Street, Suite 100, Des Moines, IA, 50316 dated August 7, 2006, for the construction of the following improvement:

M. L. King Jr. Parkway/19th Street Resurfacing - University Avenue to Hickman Road, 06-2006-009
STP-U-1945(710)--70-77, STP-U-1945(711)--70-77

The project includes milling 2-inches of the existing asphalt pavement and placing new hot mix asphalt (HMA) approximately 2.0 inches deep, patching localized pavement areas, installing pavement markings, and other incidental items; in accordance with the contract documents, including Plans File Nos. 462-061/078, on M.L.King.Jr Parkway and 19th Street from University Avenue to Mondamin Avenue and on M.L.King.Jr Parkway from Mondamin Avenue to Hickman Road

the same to be performed in accordance with the plans and specifications which have been heretofore approved by this Council, be and the same are hereby approved. The attached "Contractor's Anticipated DBE Utilization" shows the Contractor's efforts to solicit DBE Participation in accordance with the Disadvantaged Business Enterprise Program.

BE IT FURTHER RESOLVED: That the Mayor be and is hereby authorized and directed to execute said contract on behalf of the City of Des Moines, and the City Clerk, be and is hereby authorized and directed to attest to same.

BE IT FURTHER RESOLVED: That the City Clerk be and is hereby authorized and directed to return the Contractor's bid security.

BE IT FURTHER RESOLVED: That the attached communication from said Contractor requesting permission to sublet designated items and the attached Permission to Sublet form, be and are hereby approved subject to each subcontractor's compliance with the City of Des Moines Contract Compliance Program. The City Manager is hereby directed to sign said Permission to Sublet form granting permission for said listed subcontractor to work on said improvement upon each subcontractor's compliance with the City of Des Moines Contract Compliance Program as monitored by the Engineering Department.



CONTRACTOR'S ANTICIPATED DBE UTILIZATION

On July 18, 2006, Des Moines Asphalt & Paving Co., Jim Gauger, President, P.O. Box 3365, 5550 NE 22nd Street, Suite 100, Des Moines, IA 50316 submitted a proposal for construction of the M. L. King Jr. Parkway/19th Street Resurfacing - University Avenue to Hickman Road, Activity ID 06-2006-009, which the City Council has determined to be the lowest responsible, responsive bid for said project in the amount of \$609,553.78. The proposal included a statement that the Disadvantaged Business Enterprise (DBE) Program shall not apply to this project.
