AN ORDINANCE permanently vacating the public use of Hawthorne North Softball Field, located on the south side of Maury Street between SE $10^{\rm th}$ and SE $11^{\rm th}$.

WHEREAS, all prior requirements of law pertaining to the vacation of public right-of-way have been fully observed; and

WHEREAS, it is desirable that the public right-of-way herein described be vacated;

NOW, THEREFORE, BE IT ORDAINED by the City Council of the City of Des Moines, Iowa:

Section 1. That the public use of Hawthorne North Softball Field, located on the south side of Maury Street between SE $10^{\rm th}$ and SE $11^{\rm th}$, more specifically described as follows, be and is hereby vacated.

Lots 1 thru 10, Block 5, Allen's Second Addition, an Official Plat, and the vacated North/South alley lying East of and adjoining Lots 1 thru 5, of said Block 5, Allen's Second Addition, all now included in and forming a part of the City of Des Moines, Polk County, Iowa.


