## RESOLUTION APPROVING "PUD" RESTORATION BOND FOR THE SAWYER'S LANDING DEVELOPMENT

1. That Bond No. IAC 67113 in the amount of \$104,331 from the Eco-Tech as Principal, and Merchants Bonding Company (Mutual) as Surety, is hereby approved and accepted as security for the satisfactory completion of the required grading and site restoration within the Sawyer's Landing development.
