APPROVAL OF 2006 WEED AND SEED GRANT AWARD OF \$200,000 FROM THE EXECUTIVE OFFICE FOR WEED AND SEED

WHEREAS, the Department of Justice and other federal agencies are implementing Operation Weed and Seed, a comprehensive and integrated multi-agency approach to addressing violent crime, drug abuse, and deteriorating social and economic opportunities in low-income neighborhoods; and

WHEREAS, on March 27, 1995, by Roll Call No. 95-1178, the Weed and Seed Plan was integrated into the Enterprise Community Strategic Plan with the Weed and Seed boundaries being contiguous with those of the Enterprise Community and the Weed and Seed goals based on those of the Enterprise Community Plan; and

WHEREAS, the City of Des Moines, in conjunction with the U. S. Attorney's Office, neighborhood representatives and associations, and community services providers desire to continue to implement within the community a Weed and Seed program with the goal of obtaining Federal funding to support this effort; and

WHEREAS, on September 25, 1995, by Roll Call No. 95-3692, the City of Des Moines submitted an application to be designated a Weed and Seed site; and

WHEREAS, in February 1996, the City of Des Moines was notified that a portion of the City of Des Moines had been designated a Weed and Seed Site; and

WHEREAS, on April 27, 2006, the City's Housing Services Department prepared and submitted an application for 2006 Executive Office for Weed and Seed (EOWS) funding in the amount of \$200,000; and

WHEREAS, the Executive Office for Weed and Seed approved the above referenced application and approved granting the award in the amount of \$200,000.
