WHEREAS, the low dollar compliant bid for .223 caliber (69 grain) and .308 caliber rifle ammunition was received from OMB Express Police Supply, 11333 Strang Line Road, Lenexa, KS 66215; and


WHEREAS, funding is available from POL041000/Personal & Training (\$63,016.73) and POL101300/Tactical (\$88,000.00); and

WHEREAS, the Procurement Administrator and the Police Department recommend approval of the low dollar compliant bids;
