2. That if the City Council decides to vacate the above described right-of-way, the City of Des Moines proposes to sell such right-of-way, as described below to the grantees and for the consideration identified below:

To: Hubbell Properties II, L.C. for \$700

All of that portion of vacated Lot A (Northeast 47th Court), Glenn Acres, an Official Plat, lying West of and adjoining Lots 48, 49 and 50 of said Glenn Acres, all now included in and forming a part of the City of Des Moines, Polk County, Iowa.
