HOLD HEARING ON THE VACATION AND CONVEYANCE OF A DEAD-END SEGMENT OF NE 47TH COURT RIGHT-OF-WAY LOCATED SOUTH OF NE HUBBELL ROAD TO HUBBELL PROPERTIES II, L.C. (SERIES H) FOR \$700

WHEREAS, on September 11, 2006, by Roll Call No. 06-1763, the City Council adopted a recommendation from the City Plan and Zoning Commission that a dead-end segment of NE 47th Court located South of NE Hubbell Road, hereinafter more fully described, be vacated and sold; and

WHEREAS, the grantee identified below is the owner of property abutting such right-of-way and has offered to the City of Des Moines the purchase price identified below for the vacation and purchase of such right-of-way described below; and

WHEREAS, on September 25, 2006, by Roll Call No. 06- 1870, it was duly resolved by the City Council that the proposed vacation and conveyance of such right-of-way be set down for hearing on October 9, 2006, at 5:00 p.m., in the Council Chamber; and

WHEREAS, due notice of said proposal to vacate and convey public right-of-way was given as provided by law, setting forth the time and place for hearing on said proposal; and

WHEREAS, in accordance with said notice, those interested in said proposed vacation and conveyance, both for and against, have been given an opportunity to be heard with respect thereto and have presented their views to the City Council.

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Des Moines, Iowa:

1. Upon due consideration of the facts and statements of interested persons, the objections to said proposed vacation and conveyance of public right-of-way as described below are hereby overruled and the hearing is closed.

2. There is no public need for the right-of-way proposed to be vacated and the public would not be inconvenienced by reason of the vacation of a dead-end segment of NE 47th Court located South of NE Hubbell Road, more specifically described as follows:

All that portion of Lot A (Northeast 47th Court), Glenn Acres, an Official Plat, lying West of and adjoining Lots 48, 49 and 50 of said Glenn Acres, all now included in and forming a part of the City of Des Moines, Polk County, Iowa.

3. That the sale and conveyance of such right-of-way, as described below and to the grantee and for the consideration identified below, together with payment by such grantee of the estimated publication and recording costs for this transaction, be and is hereby approved:

6. The Real Estate Division Manager is authorized and directed to forward the original of the Deed, together with a certified copy of this resolution and of the affidavit of publication of the notice of this hearing, to the Polk County Recorder's Office for the purpose of causing these documents to be recorded.

7. Upon receipt of the recorded documents back from the Polk County Recorder, the Real Estate Division Manager shall mail the original of the Quit Claim Deed and copies of the other documents to the grantees.
