## ORDINANCE NO. \_\_\_\_\_

AN ORDINANCE renaming all that portion of MTA Lane right-of-way extending West from SW 9th Street in the City of Des Moines to "DART Way".

WHEREAS, the City has received a request from the Des Moines Area Regional Transit Authority (DART), formerly known as the Metropolitan Transit Authority (MTA), to rename MTA Lane to Dart Way within the City of Des Moines; NOW THEREFORE,

BE IT ORDAINED by the City Council of the City of Des Moines, Iowa:

Section 1. That the portion of the street within the City of Des Moines, Iowa, designated and known MTA Lane, extending west from SW 9th Street, is hereby renamed and shall hereafter be known as "DART Way".

- Sec. 2. That every reference in the Municipal Code of the City of Des Moines, Iowa, 2000, to MTA Lane shall be interpreted to refer to DART Way.
  - Sec. 3. The City Council finds that this amendment will affect the following official plat in

Polk County, Iowa, which is the only official plat of land directly adjoining the street hereby renamed

to DART Way: Factory Addition Plat 3, an Official Plat, City of Des Moines, Polk County, Iowa.

Sec. 4. This ordinance shall be in full force and effect from and after its passage and

publication as provided by law.

Sec. 5. The City Clerk is hereby authorized and directed to forward a certified copy of this

ordinance to the Polk County Recorder, Polk County Auditor and Polk County Assessor. The City

Clerk is hereby further authorized and directed to forward a copy of this ordinance to Qwest
