SET HEARING FOR THE VACATION AND CONVEYANCE OF A SEGMENT OF THE NORTH/SOUTH ALLEY EXTENDING SOUTH FROM EAST UNIVERSITY AVENUE BETWEEN EAST 23RD COURT AND EAST 24TH STREET TO MICHAEL L. KINTER FOR \$2,385

All of the North/South alley right-of-way lying East of and adjoining Lots 55 through 59, and lying East of and adjoining the South 11.23 feet of Lot 60, and lying South of the present South right-of-way line of East University Avenue, all in Block 6, York's Choice, an Official Plat, all now included in and forming a part of the City of Des Moines, Polk County, Iowa.

2. That if the City Council decides to vacate the above described right-of-way, the City of Des Moines proposes to sell such right-of-way, as described below, to the grantee and for the consideration identified below:


