## RESOLUTION APPROVING THE PURCHASE OF 1212 CHERRY STREET AND 1216 MULBERRY STREET

WHEREAS, the parcels at 1212 Cherry Street and 1216 Mulberry Street and then entire block bounded by Mulberry, Cherry, 12 and 13th Streets are owned by William C. Knapp, L.C. ("Knapp"); and,

BE IT RESOLVED, by the City Council of the City of Des Moines, Iowa, as follows:

- 1. The Offer to Buy Real Estate and Acceptance negotiated by the City Manager, which provides for the purchase of the parcels at 1212 Cherry Street and 1216 Mulberry Street for a purchase price of \$600,000.00, is hereby approved.
- 2. The Mayor is hereby authorized and directed to sign the said Offer to Buy Real Estate and Acceptance on behalf of the City of Des Moines, and the City Clerk is hereby authorized and directed to attest to the Mayor's signature.
