APPROVING AND AUTHORIZING THE EXECUTION OF THE FIRST AMENDMENT AND ADDENDUM TO A. H. BLANK GOLF COURSE CONCESSION MANAGEMENT AGREEMENT – A. H. BLANK GOLF COURSE IMPROVEMENTS

WHEREAS, City staff and C Corporation have negotiated a First Amendment and Addendum to construct such improvements which authorizes C Corporation to secure a twenty five (25) year loan not to exceed \$1,000,000.00 to fund the above described improvements and requires the City to assume the remaining debt if the Agreement is terminated prior to the loan repayment term.

Blank Golf Course Concession Management Agreement — A. H. Blank Golf course Improvements between C Corporation and the City of Des Moines, which is on file with the City Clerk's Office, be and is hereby approved and the Mayor is authorized and directed to sign said Amendment on behalf of the City and the City Clerk is authorized and directed to attest to the Mayor's signature.
