AN ORDINANCE vacating a segment of the North/South alley extending south from East University Avenue between East 23rd Court and East 24th Street.

WHEREAS, all prior requirements of law pertaining to the vacation of public right-of-way have been fully observed; and

WHEREAS, it is desirable that the public right-of-way herein described be vacated;

NOW, THEREFORE, BE IT ORDAINED by the City Council of the City of Des Moines, Iowa:

Section 1. That a segment of the North/South alley extending south from East University Avenue between East 23rd Court and East 24th Street, more specifically described as follows, be and is hereby vacated.

All of the North/South alley right-of-way lying East of and adjoining Lots 55 through 59, and lying East of and adjoining the South 11.23 feet of Lot 60, and lying South of the present South right-of-way line of East University Avenue, all in Block 6, York's Choice, an Official Plat, all now included in and forming a part of the City of Des Moines, Polk County, Iowa.

Sec. 2. The City of Des Moines hereby reserves an easement upon the property described above for the continued use and maintenance of any utilities now in place, with the right of entry for servicing same.

Sec. 3. That the City Clerk is hereby authorized and directed to cause certified copies of this ordinance and proof of publication thereof together with proof of publication of the notice of the public hearing on this matter to be properly filed in the office of the Recorder of Polk County, Iowa.
