HOLD HEARING FOR THE VACATION AND CONVEYANCE OF THE DEAD-END NORTH/SOUTH ALLEY EXTENDING SOUTH FROM SCOTT STREET BETWEEN SE 6TH AND SE 7TH STREETS TO OSCAR AND ANGELICA PADILLA FOR \$3,030 AND TO SOPOPA MARTINEZ FOR \$50

WHEREAS, on September 11, 2006, by Roll Call No. 06-1760, the City Council adopted a recommendation from the City Plan and Zoning Commission that the dead-end North/South alley extending south from Scott Street between SE 6th and SE 7th Streets, hereinafter more fully described, be vacated and sold; and

WHEREAS, the grantees identified below are the owners of property abutting such right-of-way and have offered to the City of Des Moines the purchase price identified below for the vacation and purchase of such right-of-way described below; and

WHEREAS, on December 4, 2006, by Roll Call No. 06-2372, it was duly resolved by the City Council that the proposed vacation and conveyance of such right-of-way be set down for hearing on December 18, 2006, at 5:00 p.m., in the Council Chamber; and

WHEREAS, due notice of said proposal to vacate and convey public right-of-way was given as provided by law, setting forth the time and place for hearing on said proposal; and

WHEREAS, in accordance with said notice, those interested in said proposed vacation and conveyance, both for and against, have been given an opportunity to be heard with respect thereto and have presented their views to the City Council.

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Des Moines, Iowa:

1. Upon due consideration of the facts and statements of interested persons, the objections to said proposed vacation and conveyance of public right-of-way, as described below, are hereby overruled and the hearing is closed.

2. There is no public need for the right-of-way proposed to be vacated and the public would not be inconvenienced by reason of the vacation of the dead-end North/South alley extending south from Scott Street between SE 6th and SE 7th Streets, more specifically described as follows:

All of the North/South alley right-of-way lying West of and adjoining Lots 7, 8, 9 and 10, Block 54, Town of De Moine, an Official Plat, all now included in and forming a part of the City of Des Moines, Polk County, Iowa.

All of the vacated North/South alley right-of-way lying West of and adjoining Lots 8, 9 and 10, Block 54, Town of De Moine, an Official Plat, all now included in and forming a part of the City of Des Moines, Polk County, Iowa.

To: Sopopa Martinez for \$50

All of the vacated North/South alley right-of-way lying East of and adjoining Lot 4, Block 54, Town of De Moine, an Official Plat, all now included in and forming a part of the City of Des Moines, Polk County, Iowa.

4. The Mayor is authorized and directed to sign the Offer to Purchase and the Quit Claim Deed for the conveyances identified above, and the City Clerk is authorized and directed to attest to the Mayor's signature.

5. Upon final passage of an ordinance vacating the said right-of-way and upon proof of payment of the consideration plus \$113.00 for publication and recording costs, the City Clerk is authorized and directed to forward the originals of the said Deeds, together with a certified copy of this resolution and of the affidavit of publication of the notice of this hearing to the Real Estate Division of the Engineering Department for the purpose of causing said documents to be recorded.

6. The Real Estate Division Manager is authorized and directed to forward the originals of the Deeds, together with a certified copy of this resolution and of the affidavit of publication of the notice of this hearing, to the Polk County Recorder's Office for the purpose of causing these documents to be recorded.

7. Upon receipt of the recorded documents back from the Polk County Recorder, the Real Estate Division Manager shall mail the originals of the Quit Claim Deeds and copies of the other documents to the grantees.
