**RESOLUTION APPROVING AMENDMENT
TO EMBASSY SUITES PARKING LOT LEASE AGREEMENT**

WHEREAS, the City of Des Moines as landlord has leased the real property locally known as 100 E. Locust Street and improved as the Embassy Suites Parking Lot to John Q. Hammons, the predecessor in interest to John Q. Hammons Hotels, L.P., a Delaware Limited Partnership, under a Lease Agreement dated May 1, 1989, recorded at Book 6101, Page 866 in the real estate records of Polk County, Iowa and by way of that Memorandum of Lease dated October 22, 1990 recorded at Book 6317, Page 988 of said records, as assigned by John Q. Hammons to John Q. Hammons Hotels, L.P. by Assignment of Lessee's Interest in Lease dated May 21, 2002, and recorded in the office of the Polk County Recorder at Book 9159, Page 894 ("the Parking Lot Lease"); and

WHEREAS, on February 20, 2006, by Roll Call No. 06-360, the City Council of the City of Des Moines approved a further assignment of the Parking Lot Lease to Atrium Finance III, L.P. ("Lessee"), the current owner of the adjoining Embassy Suites Hotel and a wholly owned subsidiary of Atrium Hotels, L.P., formerly known as John Q. Hammons Hotels, L.P.; and

WHEREAS, the twentieth year of the thirty-year lease term of the Parking Lot Lease commenced on October 3, 2010, and pursuant to the terms of said Lease and amendments thereto, the annual rental amounts were not provided for lease years 21 through 30 of the lease term and rather are to be calculated upon reaching said lease years; and

WHEREAS, the City's Real Estate Division has negotiated an Amendment to Lease Agreement, on file in the office of the City Clerk, which Amendment has been approved and executed by Lessee and establishes the annual rental amount of \$74,100.00 per year for lease years 21 through 25 of the Parking Lot Lease, which amount reflects fair market rental rates for the leased property, and which Amendment further sets forth the terms for establishing annual rental amounts for lease years 26 through 30 based on reevaluation by the City's Real Estate Division Manager.

NOW, THEREFORE, it is hereby resolved by the City Council of the City of Des Moines, Iowa, that the Amendment to Lease Agreement between the City of Des Moines and Atrium Finance III, L.P. for the real property locally known as 100 E. Locust Street and improved as the Embassy Suites Parking Lot is hereby approved, the Mayor is authorized and directed to sign the Amendment, and the Clerk is directed to attest to his signature and to forward the Amendment to the City's Real Estate Division for recording with the Polk County Recorder.

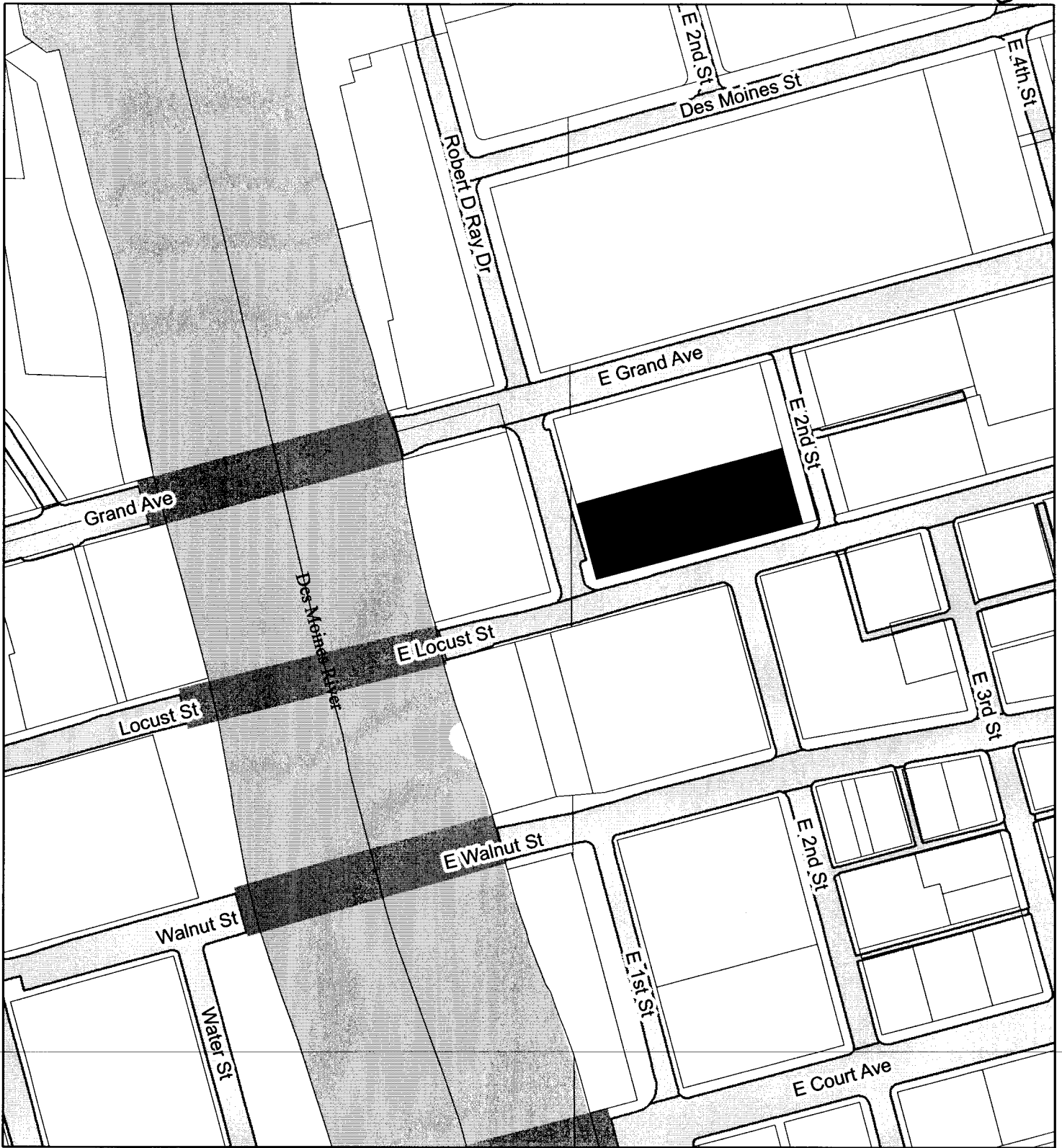
