WHEREAS, the Public Works Department wishes to utilize a secondary supplier when the primary supplier is unable to provide services in the time requested; and

WHEREAS, the second low dollar compliant bid was received from McAninch Corporation, 4001 Delaware, Des Moines, IA 50313, Douglas McAninch, President; and

WHEREAS, funding is available from PWK071600/Storm Sewer Maintenance for an annual estimated amount up to \$250,000.00; and

WHEREAS, the Procurement Administrator and the Public Works Department recommend approval of the low dollar compliant bids;

NOW THEREFORE BE IT RESOLVED, that the Des Moines City Council hereby accepts and approves the award to the aforementioned bidders, and further authorizes the Procurement Administrator to enter into annual agreements renewable for two (2) additional twelve (12) month periods.
