WHEREAS, the Street Maintenance Division of the Public Works Department, along with the City of West Des Moines, Polk County and 20 other public entities representing the Central Iowa Salt Group (CISG) wished to solicit joint bids for rock salt for delivery to the metropolitan salt storage facility, and to individual CISG agencies storage facilities; and

WHEREAS, the City of West Des Moines through its Public Works Department, on behalf of CISG, solicited invitation for bids by advertisement and mailing to ten (10) potential bidders with three (3) bids received; and

WHEREAS, the CISG awarded one year agreements to the low dollar compliant bidders, with options to renew for an additional two (2) years in twelve (12) month increments; and

WHEREAS, Roll Call # 12-0904 dated June 11, 2012 approved an award to the low dollar compliant bidder for rock salt delivered to the Metropolitan Salt Storage Facility (\$55.91 per ton), from Hutchinson Salt Co., 136 W. 12th Street, Baxter Springs, KS 66713, Larry Bingham, President, for rock salt needs for the 2012/2013 winter season; and

WHEREAS, the CISG has opted to renew the existing contracts for the first twelve (12) month period with revised rates of \$57.03 per ton delivered (plus a fuel escalator) to the City of Des Moines Public Works Storage Facility and \$57.03 per ton delivered (plus a fuel escalator) to the Metropolitan Salt Storage Facility; and

WHEREAS, Municipal Code section 2-726(f) authorizes the procurement of goods and/or services from contracts that have been competitively established through cooperative group contracting consortiums for state government departments, institutions, agencies and political subdivisions, without conforming to the competitive bidding requirements of the Procurement Division; and

WHEREAS, funding is available from PWK040400/Street Maintenance for the 2013/2014 winter season;

NOW THEREFORE BE IT RESOLVED, that the Des Moines City Council hereby accepts and approves the twelve month contract renewal with Hutchinson Salt Co. at the revised contract rates for a total cost of \$870,450.00.
