**RESOLUTION APPROVING DOCUMENTS RELATED TO A NEIGHBORHOOD COMMERCIAL REVITALIZATION PROGRAM (NCR) LOAN FOR \$170,000 AND A FAÇADE GRANT FOR \$15,000 TO GASSMANN REAL ESTATE, LLC FOR RENOVATIONS AND EXPANSION OF THE COMMERCIAL BUILDING AT 2822 & 2806 6<sup>TH</sup> AVENUE, DES MOINES**

WHEREAS, Gassmann Real Estate, LLC (hereinafter referred to as Developer) by Charles J Gassmann, Manager, has made an application for a Neighborhood Commercial Revitalization Program Loan (NCR) for \$170,000 and Neighborhood Commercial Revitalization Façade Grant for \$15,000 to support the renovations and expansion of the commercial buildings located at 2822 and 2806 6<sup>th</sup> Avenues; and

WHEREAS, the proposed project will assist in revitalizing the area by enhancing the value of the commercial property; and

WHEREAS, Developer will be responsible for all additional costs associated with cost overruns for all improvements to the commercial buildings located at 2822 and 2806 6<sup>th</sup> Avenue, Des Moines, Iowa.

WHEREAS, Developer will undertake renovations and improvements to the commercial building totaling approximately \$626,000, the Developer has obtained all other needed financing for the project, and the Developer will be responsible for all additional costs and overruns for improvements to the site; and

WHEREAS, the Developer has executed the attached NCR Loan and Façade Grant Agreement, Promissory Note, Mortgage and Personal Guaranty the City Council finds the form of the attached documents to be acceptable.

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Des Moines, Iowa:

1. That approval is given for a NCR Loan in the amount of \$170,000 and a Façade Grant in the amount of 15,000.00, under the terms and conditions as outlined in the City Council communication, which by this referenced is made a part hereof, with such loan contribution to be expressly contingent upon meeting all environmental review requirements and NCR program requirements.
2. The documents are hereby approved and the Mayor is authorized and directed to sign the attached documents and the City Clerk is authorized to attest to the Mayor's signature and to obtain proper acknowledgment.


