AN ORDINANCE to amend the Official Zoning Map of the City of Des Moines, Iowa, set forth in Section 134-277 of the Municipal Code of the City of Des Moines, Iowa, 2000, by rezoning and changing the district classification of certain property located in the vicinity of 3629 59th Street from the R-3 Multiple Residential District to a Limited C-2 General Retail and Highway Oriented Commercial District classification.

Be It Ordained by the City Council of the City of Des Moines, Iowa:

Section 1. That the Official Zoning Map of the City of Des Moines, Iowa, set forth in Section 134-277 of the Municipal Code of the City of Des Moines, Iowa, 2000, be and the same is hereby amended by rezoning and changing the district classification of certain property located in the vicinity of 3629 59th Street, more fully described as follows, from the R-3 Multiple Residential District to a Limited C-2 General Retail and Highway Oriented Commercial District classification:

The North 83 feet of the West 109.78 feet, Lot 40, Clover Acres, an Official Plat, all now included in and forming a part of the City of Des Moines, Polk County, Iowa.

Section 2. That this ordinance and the zoning granted by the terms hereof are subject to the following imposed additional conditions which have been agreed to and accepted by execution of an Acceptance of Rezoning Ordinance by all owners of said property and are binding upon the owners and their successors, heirs, and assigns as follows:

- 1) The following uses of the land and structures shall not be permitted upon the Property:
 - a. Adult entertainment business.
 - b. Delayed deposit services businesses.
 - c. General motor vehicle repair.
 - d. Liquor stores.
 - e. Off premises advertising signs.
 - f. Pawnbroker.
 - g. Taverns and nightclubs.
 - h. Vehicle display lot.

2) No building shall be constructed on the southern 25 feet of the subject property so long as the adjoining property to the south is within an "R" District.

Section 3. This ordinance shall be in full force and effect from and after its passage and

publication as provided by law.

Section 4. The City Clerk is hereby authorized and directed to cause a certified copy of

- 4. That in the event any portion of the Property is hereafter rezoned to a district classification different from Limited C-2, then this Acceptance shall be immediately terminated as applied to the real estate so rezoned on the effective date of such rezoning, and the conditions agreed to herein shall be rendered null and void, provided, if there be any such rezoning to a more restricted zoning classification, any then legal actual use of such real estate shall become a legal non-conforming use.
