

Re: Proposed adoption to require protection of lightweight floor joists.

Dear Honorable Mayor and Members of the Des Moines City Council:

I am writing to you to as chairperson of the Des Moines Building and Fire Appeals Board in regards to the proposed protection of lightweight floor joists. Over the past three months we have had open discussion opportunities for this proposed code change. The first occurred in the form of a public meeting on April 11, followed by our normal board meeting on May 9th. Mr. Cox was aware of the public meeting in April and was not in attendance. He was then invited to come and speak to the board on behalf of the Home Builders Association of Greater Des Moines in May, which again went unattended. This item was discussed in May followed by a motion to accept the proposed protection requirements and a vote in favor of doing so. After that meeting, via a phone conversation, I personally invited him to attend our June 13th meeting. Although this was considered closed, I felt it in the best interest to reopen it on his behalf and put it on the agenda for that meeting. On the day of the June meeting, we were informed that he would not be attending due to a birthday for his son. There was further discussion on this topic with the result still in favor of keeping the proposed code change.

I am aware that some other jurisdictions have elected to strike this from the residential code due to the anticipated cost factors. While I do agree there could be added costs in keeping this provision in the code as written, I also believe that the additional costs involved spread out over the cost of the home is a small percentage and certainly affords additional protection to the occupants and to the firefighters that may have to enter the home during a fire. I think this portion of the code provides a responsible approach to the issue of lightweight construction and the safety factors involved outweigh the financial impact on a typical project utilizing this method.

I would like to mention that this board is made up of a group of volunteers, all with backgrounds in the building industry, who as a group meet to review building codes and issues to help insure the safety of the community. Speaking for the majority of the board, we feel there were adequate opportunities to represent opposing arugments, none of which were taken and this provision of the code should remain as proposed. Additionally we feel the safety should not be forsaken for the financial gain in this case.
