RESOLUTION ACCEPTING EASEMENT REQUIRED AS A CONDITION OF CITY APPROVAL OF A PLAT OF SURVEY OF PROPERTY IN THE VICINITY OF 6550 BLOOMFIELD ROAD

WHEREAS, Bloomfield Development Company, LLC, represented by Rick R. Messerschmidt, Managing Member, have presented a Plat of Survey of land in the vicinity of 6550 Bloomfield Road for approval by the City in accordance with the City's Subdivision Regulations; and,

WHEREAS, the City Engineer recommends that the dedication of the Permanent Easement for Sanitary Sewer Right-of-way be approved and accepted by the City; NOW, THEREFORE,

1. The Permanent Easement for Sanitary Sewer Right-of-way from Bloomfield Development Company for the use of the easement area described below is hereby approved:
