Re: Report to Council

Pursuant to the authority and direction of Council authorizing the City Attorney to settle claims, lawsuits and workers compensation actions for a total sum not to exceed \$5,000, I submit to Council the following summary report of settlements made:

METLIFE AUTO & HOME, \$3,332.51 in payment of subrogation claim for vehicle damage, car rental expense and collision deductible resulting from incident on March 28, 2013 when City Park's employee rear-ended van on I-235.

NICOLE HOLLINGSHEAD AND HER ATTORNEY, RICK L. OLSON, \$4,000.00 as a settlement for a lawsuit regarding incident of May 26, 2010 when a child suffered burns from a slide in Brook Run Park.

KARIANN MIKESELL, AS PARENT, AND LAMARCA & LANDRY, P.C., \$5,000.00 in payment of claim for bodily injury resulting from incident of June 6, 2011 when a child cut her foot on a piece of glass in the wading pool at Chesterfield Pool.

FISHER BODY & PAINT, \$3,096.30 for repairs to claimant's vehicle resulting from incident of May 3, 2013 when employee was plowing snow in the City Hall parking lot and backed into vehicle; ENTERPRISE RENT A CAR, \$155.34 for rental car expense.

LUZ AMANDA TORRES, \$3,505.00 for bodily injury and lost wages resulting from incident on March 3, 2013 when police officer rear-ended claimant on Easton at University Avenue; \$447.40 was previously paid for property damage.

MVP FENCE \$597.00 for damaged chain link fence at 1436 Thompson Avenue, owned by Cody McDaniel and Mattie Thomsen, which was damaged by pick-up arm of City garbage truck on May 14, 2013.

ANDREW WARD \$864.03 for property damage to Claimant's parked vehicle on May 24, 2013 when City garbage collector struck the vehicle while emptying a large dumpster on 17th Street.
