APPROVING AN EXCEPTION TO THE PROCUREMENT ORDINANCE COMPETITIVE BIDDING REQUIREMENTS FOR GOOD CAUSE AND APPROVING PROFESSIONAL SERVICES CONTRACT WITH ETC INSTITUTE FOR THE DEVELOPMENT AND IMPLEMENTATION OF THE 2013 RESIDENT AND BUSINESS SATISFACTION SURVEYS

WHEREAS, satisfaction surveys are an important source of citywide resident and business input regarding city services and quality of life in Des Moines; and

WHEREAS, the City Council previously authorized four successful resident satisfaction surveys (2004, 2005, 2006, and 2007) and resident and business surveys in 2008 and 2011 with ETC Institute; and

WHEREAS, the results of ETC Institute *Direction Finder* surveys can be benchmarked against results from communities across the nation; and

WHEREAS, City staff have negotiated a Contract for services and Scope of Work with ETC Institute in the amount of \$33,250.00, which is the same fee as for the 2008 and 2011 surveys; and

WHEREAS, the City Manager recommends that the procurement of survey development and implementation services for resident and business surveys be exempted from the competitive bidding requirements for good cause shown, pursuant to Section 2-710(a) of the Municipal Code of the City of Des Moines.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF DES MOINES, IOWA:

1. That good cause has been shown to exempt the procurement of the above described survey services from the Procurement Ordinance competitive bidding requirements.
2. That the City Council hereby accepts and approves the procurement of services for the above described survey services from and hereby approves the Contract for Services and Scope of Work, a copy of which is on file in the City Clerk's Office, in the amount of \$33,250.00, and authorizes and directs the City Manager to execute same on behalf of the City.
