AN ORDINANCE to amend the Municipal Code of the City of Des Moines, Iowa, 2000, adopted by Ordinance No. 13,827, passed June 5, 2000, as heretofore amended, is hereby amended by amending Sections 114-2781, 114-3268, 114-3925.7, 114-3925.9, 114-4027 and 114-4097, relating to traffic and vehicle regulations.

Be It Ordained by the City Council of the City of Des Moines, Iowa:

Section 1. That the Municipal Code of the City of Des Moines, Iowa, 2000, adopted by Ordinance No. 13,827, passed June 5, 2000, as heretofore amended, is hereby amended by amending Sections 114-2781, 114-3268, 114-3925.7, 114-3925.9, 114-4027 and 114-4097, relating to traffic and vehicle regulations, as follows:

**Sec. 114-2781. Eighteenth Street--Locust Street to Ingersoll Avenue.**

Eighteenth Street, on both sides, from Locust Street to Grand Avenue, no stopping or standing.

Eighteenth Street, on the east side, from Grand Avenue to a point 35 feet north thereof, no parking any time.

Eighteenth Street, on the east side, 82 feet north of Grand Avenue to a point 30 feet north thereof, commercial loading zone.

**Sec. 114-3268. East Grand Avenue--Robert D Ray Drive to East Fourth Street.**

East Grand Avenue, on the north side, from Robert D Ray Drive to a point 195 feet east thereof, reserved for city of Des Moines municipal employee permit parking, 7:00 a.m. to 4:00 p.m., Monday through Friday.

East Grand Avenue, on the north side, from a point 350 feet east of Robert D Ray Drive to a point 135 feet west of East Fourth Street, no parking any time.

East Grand Avenue, on the south side, from Robert D Ray Drive to a point 345 feet east thereof, reserved for city of Des Moines municipal employee permit parking, 7:00 a.m. to 4:00 p.m., Monday through Friday.

East Grand Avenue, on the south side, from East Second Street to a point 20 feet east thereof, no parking any time.

East Grand Avenue, on the south side, from a point 220 feet east of East Second Street to a point 70 feet east thereof, no parking anytime.

East Grand Avenue, on the south side, from East Fourth Street to a point 62 feet west thereof, loading zone.

**Sec. 114-3925.7. Locust Street--Eighth Street to Ninth Street.**

Locust Street, on the south side, from Eighth Street to a point 57 feet west, two-hour meters, 9:00 a.m. to 4:00 p.m.

Locust Street, on the south side, from a point 162 feet west of Eighth Street to Ninth Street, two-hour meters, 9:00 a.m. to 4:00 p.m.

Locust Street, on the north side, from a point 200 feet west of Eighth Street to Ninth Street, two-hour meters, ~~9:00~~ 8:00 a.m. to 4:00 p.m.

**Sec. 114-3925.9. Locust Street--Ninth Street to Tenth Street.**

Locust Street, on the south side, from a point 110 feet west of Ninth Street to Tenth Street, two-hour meters, 9:00 a.m. to 4:00 p.m.

Locust Street, on the north side, from Ninth Street to a point 140 feet west thereof, two-hour meters, 8:00 a.m. to 6:00 p.m. ~~9:00 a.m. to 4:00 p.m.~~

Locust Street, on the north side, from a point 200 feet west of Ninth Street to Tenth Street, two-hour meters, 8:00 a.m. to 6:00 p.m. ~~9:00 a.m. to 4:00 p.m.~~

**Sec. 114-4027. Locust Street--Twelfth Street to Thirteenth Street.**

Locust Street, on the south side, from Twelfth Street to a point 109 feet west thereof, four-hour meters, 9:00 a.m. to 6:00 p.m.

Locust Street, on the south side, from a point 200 feet west of Twelfth Street to Thirteenth Street, four-hour meters, 9:00 a.m. to 6:00 p.m.

Locust Street, on the north side, from a point 20 feet west of Twelfth Street to a point 25 feet east of Thirteenth Street, four-hour meters, ~~9:00~~ 8:00 a.m. to 6:00 p.m.

**Sec. 114-4097. East Grand Avenue--Des Moines River Bridge to East Fourth Street.**

East Grand Avenue, on the south side, from Des Moines River Bridge to a point 45 feet west of Robert D Ray Drive, two-hour meters, 8:00 a.m. to 6:00 p.m.

East Grand Avenue, on the south side, from a point 45 feet west of Robert D. Ray Drive to a point 55 feet west thereof, parking meters EG-007a and EG-007b, two-hour meters, 8:00 a.m. to 6:00 p.m., are designated handicapped parking spaces and are subject to the same prohibition as is found in subsection 114-616(a) of this chapter.

East Grand Avenue, on the north side, from East Fourth Street to a point 135 feet west thereof, two-hour meters, 9:00 a.m. to 6:00 p.m.

East Grand Avenue, on the south side, from a point 20 feet east of East Second Street to a point 200 feet east, thereof, ~~62 feet west of East Fourth Street,~~ four-hour meters, 8:00 a.m. to 6:00 p.m.

East Grand Avenue, on the south side, from a point 290 feet east of East Second Street to a point 62 feet west of East Fourth Street, four-hour meters, 8:00 a.m. to 6:00 p.m.

Section 2. This ordinance shall be in full force and effect from and after its passage and publication as provided by law.
