AMENDMENT TO PROCEDURAL RULES OF DES MOINES CITY COUNCIL

Rule 42A. Waiver of Ordinance Readings.

A Council member may move the final passage of an ordinance, with ~~waiver of first or second consideration of the ordinance or waiver or both,~~ and suspension of the requirement that an ordinance must be considered and voted on for passage at two Council meetings prior to the meeting at which it is to be finally passed, by reciting the following motion:

"Moved by (insert the moving Council member's name) that the rule requiring that an ordinances must be considered and voted on for passage at two Council meetings prior to the meeting at which it is to be finally passed be suspended, ~~that the first and second consideration and vote be waived;~~ that the ordinance be placed upon its final passage and that the ordinance do now pass."

or may move waiver and suspension by reference to the language of this section to be known as "the waiver rule".

Re: Amendment to Procedural Rule 42A - Waiver of Ordinance Readings

In my letter to the City Council dated September 13th, I concluded that based on 1997 amendments to the Iowa Code, Council Members need not concern themselves with "pre-published" or "non-pre-published" rules for passage of an ordinance without three readings of same. In the process of preparing the Amendment to Rule 42A relating to waiver of ordinance readings, it was discovered that the City Council in 2005 had amended this rule to remove the distinction between pre-published and non-pre-published rules with the intention of conforming to the 1997 Iowa Code amendment. Unfortunately, the City Attorney Council Book did not contain the updated rule, having only an older version.

Upon review of Rule 42A, as amended, the Legal Department has determined that this rule should be again revised to more closely align with the language contained in the Iowa Code and current City Council practice for the consideration and passage of ordinances.

An Amendment to Procedural Rules of Des Moines City Council to amend Rule 42A is presented for consideration by the City Council. In accordance with the Amendment, Council Members can simply move to waive and suspend the requirement for three readings of an ordinance by referring to Rule 42A or "the waiver rule."
