AN ORDINANCE to amend the Municipal Code of the City of Des Moines, Iowa, 2000, adopted by Ordinance No. 13,827, passed June 5, 2000, as heretofore amended, is hereby amended by amending Section 114-241, relating to the traffic safety advisory committee.

Be It Ordained by the City Council of the City of Des Moines, Iowa:

Section 1. That the Municipal Code of the City of Des Moines, Iowa, 2000, adopted by Ordinance No. 13,827, passed June 5, 2000, as heretofore amended, is hereby amended by amending Section 114 -241 relating to the traffic safety advisory committee, as follows:

Sec. 114-241. Created; composition; appointment; terms.

- (a) There is established in and for the city a traffic safety advisory committee.
- (b) The traffic safety advisory committee shall consist of <u>eleven nine</u> voting members. <u>Seven Eight</u> of the members shall be appointed by the city council. <u>One member shall be appointed by each council member with two members appointed by the Mayor. One member shall be appointed by the superintendent of the Des Moines Independent Community School District to represent the interest of the schools citywide. <u>Three of the members shall be ex officio members, consisting of the following officials or their designees: the chief of police, the city engineer, and the superintendent of the Des Moines Independent Community School District.</u></u>
- (c) The term of office of each of the <u>seven</u> <u>eight</u> appointed members of the traffic safety advisory committee shall be for staggered terms of three years. The expiration date for all terms of appointed members shall be December 31. Each member of the city council may recommend a candidate to fill one position on the board.

Section 2. This ordinance shall be in full force and effect from and after its passage and publication as provided by law.
