WHEREAS, the Procurement Division solicited bids by advertisement and mailing Invitation to Bid V14-029 to two (2) potential bidders with two (2) bids received; and

WHEREAS, the low dollar compliant bid was received from Des Moines Asphalt & Paving Co., 2401 SE Tones Drive, Ankeny, IA 50021, (Jim Gauger/President) at a total annual estimated cost of \$186,750.00; and


WHEREAS, funding is available from PW240402/ Street Maintenance; and
