AN ORDINANCE to amend the Municipal Code of the City of Des Moines, Iowa, 2000, adopted by Ordinance No. 13,827, passed June 5, 2000, as heretofore amended, is hereby amended by repealing Section 114-672 and by amending Sections 114-3063, 114-3268, 114-3575 and 114-4097, relating to traffic and vehicle regulations.

Be It Ordained by the City Council of the City of Des Moines, Iowa:

Section 1. That the Municipal Code of the City of Des Moines, Iowa, 2000, adopted by Ordinance No. 13,827, passed June 5, 2000, as heretofore amended, is hereby amended by repealing Section 114-672 and by amending Sections 114-3063, 114-3268, 114-3575 and 114-4097, relating to traffic and vehicle regulations, as follows:

**Sec. 114-672. 425 E. Grand Municipal Parking Lot Repealed by Ord. No. 15,---**

~~(a) The city engineer is hereby authorized and directed to install parking meters in the following described municipally-owned parking lot:~~

~~Lot 2 and 3, Block 9, East Fort Des Moines; in the City of Des Moines, Iowa.~~

~~for the purpose of, and in such numbers, and at such places as may be necessary to the regulation, control and inspection of the parking of vehicles therein, subject to division 6 of this article, regulating parking meters.~~

~~(b) When installed, such parking meters shall be in operation between the hours of 8:00 a.m. and 6:00 p.m., Mondays through Fridays. Effective January 1, 2006 these parking meters shall conform to the parking meter rates listed in Parking Meter District III, as is found in section 114-643 of this code.~~

~~(c) The following rate shall be charged for reserved monthly parking 8:00 a.m. until 6:00 p.m., Mondays through Fridays.~~

**Sec. 114-3063. Center Street--Twelfth Street to Martin Luther King Jr Parkway.**

Center Street, on both sides, from Twelfth Street to Fifteenth Street, no parking any time.

Center Street, on the south side, from Fifteenth Street to a point 50 feet west thereof, no parking any time.

Center Street, on the south side, from a point 115 feet west of Sixteenth Street to a point 25 feet west thereof, no parking any time.

Center Street, on the south side, from Nineteenth Street to Martin Luther King Jr Parkway, no parking any time.

Center Street, on the north side, from Martin Luther King Jr Parkway to a point 60 feet east thereof, no parking any time.

**Sec. 114-3268. East Grand Avenue--Robert D Ray Drive to East Fourth Street.**

East Grand Avenue, on the north side, from Robert D Ray Drive to a point 195 feet east thereof, reserved for city of Des Moines municipal employee permit parking, 7:00 a.m. to 4:00 p.m., Monday through Friday.

East Grand Avenue, on the north side, from a point ~~350~~ 315 feet east of Robert D Ray Drive to a point ~~135~~ 217 feet east thereof west of East Fourth Street, no parking any time.

East Grand Avenue, on the north side, from a point 195 feet east of Robert D Ray Drive to a point 120 feet east thereof, no parking 7:00 a.m. to 6:00 p.m., Monday through Friday.

East Grand Avenue, on the south side, from Robert D Ray Drive to a point ~~345~~ 240 feet east thereof, reserved for city of Des Moines municipal employee permit parking, 7:00 a.m. to 4:00 p.m., Monday through Friday.

East Grand Avenue, on the south side, from East Second Street to a point 20 feet east thereof, no parking any time.

East Grand Avenue, on the south side, from a point ~~220~~ 200 feet east of East Second Street to a point ~~70~~ 90 feet east thereof, no parking any time.

East Grand Avenue, on the north side, from a point 135 feet west of East Fourth Street to a point 260 feet west thereof, no parking 7:00 a.m. to 6:00 p.m., Monday through Friday.

East Grand Avenue, on the south side, from East Fourth Street to a point 62 feet west thereof, loading zone.

**Sec. 114-3575. Pleasant Street--Tenth Street to Martin Luther King Jr Parkway.**

Pleasant Street, on the north side, from Tenth Street to a point 85 feet west thereof, no parking any time.

Pleasant Street, on the south side, from Tenth Street to a point 140 feet west thereof, no parking any time.

Pleasant Street, on the west side, from a point 230 feet west of Tenth Street to a point 270 feet north thereof, no parking any time.

Pleasant Street, on the south side, from Fourteenth Place to a point 50 feet west of Fifteenth Street, no parking any time.

Pleasant Street, on the north side, from Fourteenth Place to Fifteenth Street, no parking any time.

Pleasant Street, on both sides, from a point 50 feet east of Sixteenth Street to a point 50 feet west of Sixteenth Street, no parking any time.

Pleasant Street, on the north side, from a point 160 feet west of Sixteenth Street to a point 25 feet west thereof, no parking any time.

Pleasant Street, on both sides, from a point 50 feet east of Seventeenth Street to a point 50 feet west of Seventeenth Street, no parking any time.

Pleasant Street, on the south side, from a point 130 feet east of Seventeenth Street to a point 40 feet east thereof, commercial loading zone.

Pleasant Street, on the south side, from a point 170 feet west of Seventeenth Street to a point 30 feet west thereof, is designated a handicapped parking space and is subject to the same prohibition as is found in subsection 114-616(a) of this chapter.

Pleasant Street, on both sides, from a point 50 feet east of Eighteenth Street to a point 50 feet west of Eighteenth Street, no parking any time.

Pleasant Street, on the north side, from Nineteenth Street to a point 50 feet east thereof, no parking any time.

Pleasant Street, on the south side, from Nineteenth Street to a point 50 feet east, no parking any time.

Pleasant Street, on the south side, from Twentieth Street to Martin Luther King Jr Parkway, no parking any time.

**Sec. 114-4097. East Grand Avenue--Des Moines River Bridge to East Fourth Street.**

East Grand Avenue, on the south side, from Des Moines River Bridge to a point 45 feet west of Robert D Ray Drive, two-hour meters, 8:00 a.m. to 6:00 p.m.

East Grand Avenue, on the south side, from a point 45 feet west of Robert D. Ray Drive to a point 55 feet west thereof, parking meters EG-007a and EG-007b, two-hour meters, 8:00 a.m. to 6:00 p.m., are designated handicapped parking spaces and are

subject to the same prohibition as is found in subsection 114-616(a) of this chapter.

East Grand Avenue, on the north side, from East Fourth Street to a point 135 feet west thereof, two-hour meters, 9:00 a.m. to 6:00 p.m.

East Grand Avenue, on the south side from a point 240 feet east of Robert D Ray Drive to a point 65 feet east thereof, four-hour meters, 8:00 a.m. to 6:00 p.m.

East Grand Avenue, on the south side, from a point 20 feet east of East Second Street to a point ~~200~~ 180 feet east, thereof, four-hour meters, 8:00 a.m. to 6:00 p.m.

East Grand Avenue, on the south side, from a point 290 feet east of East Second Street to a point 62 feet west of East Fourth Street, four-hour meters, 8:00 a.m. to 6:00 p.m.

Section 2. This ordinance shall be in full force and effect from and after its passage and publication as provided by law.

**DES MOINES TRAFFIC REGULATION CHANGES**

Amending Chapter 114 of the Municipal Code Regarding Traffic Regulation Changes as follows:

- A. Additional Metered Parking—Vicinity of East 4th Street and East Grand Avenue.
- B. Deletion of the 425 East Grand Avenue Parking Lot
- C. Parking Restriction—North Side of Pleasant Street West of 16th Street.
- D. Parking Restriction—South Side of Center Street West of 16th Street.

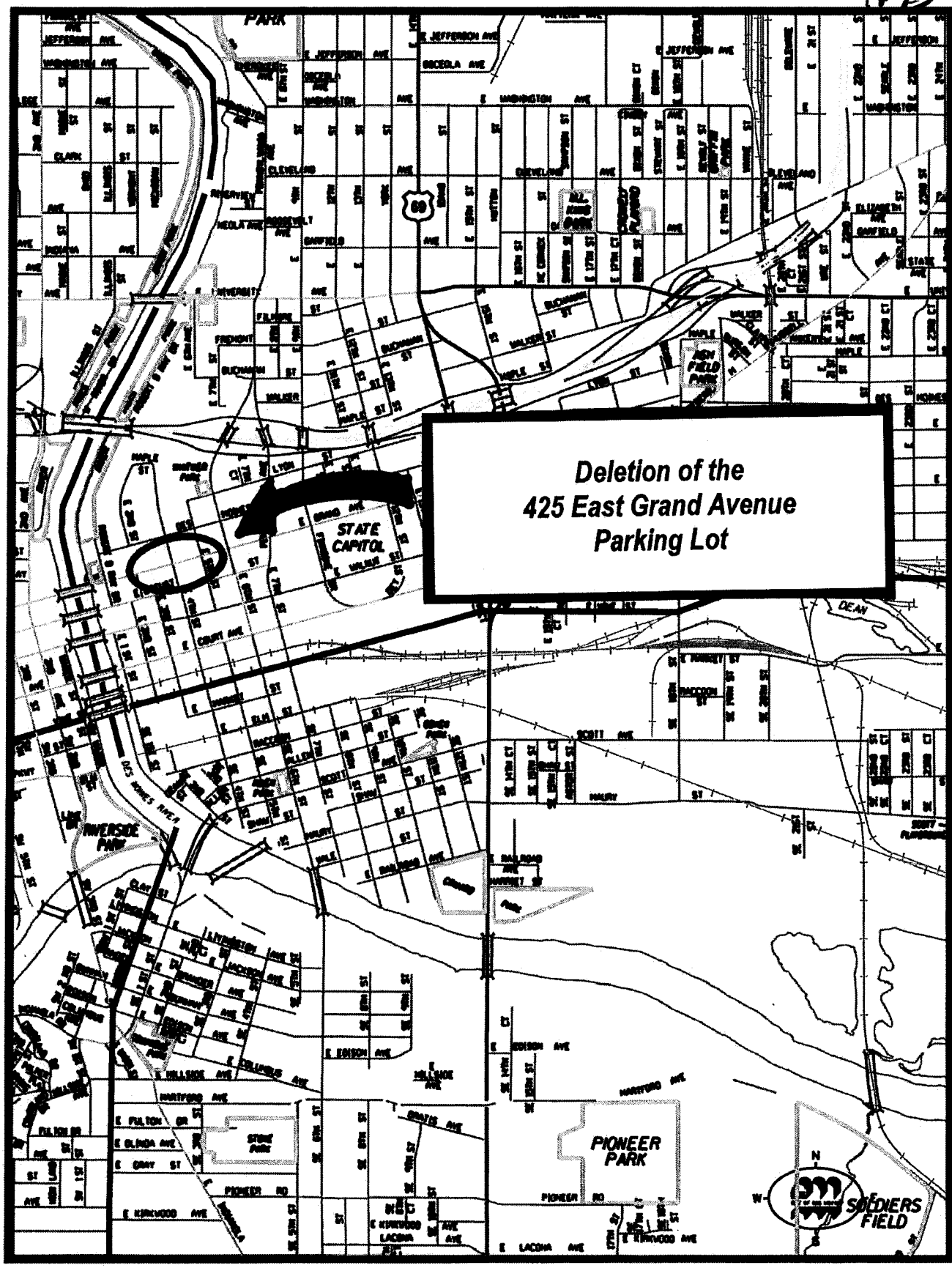

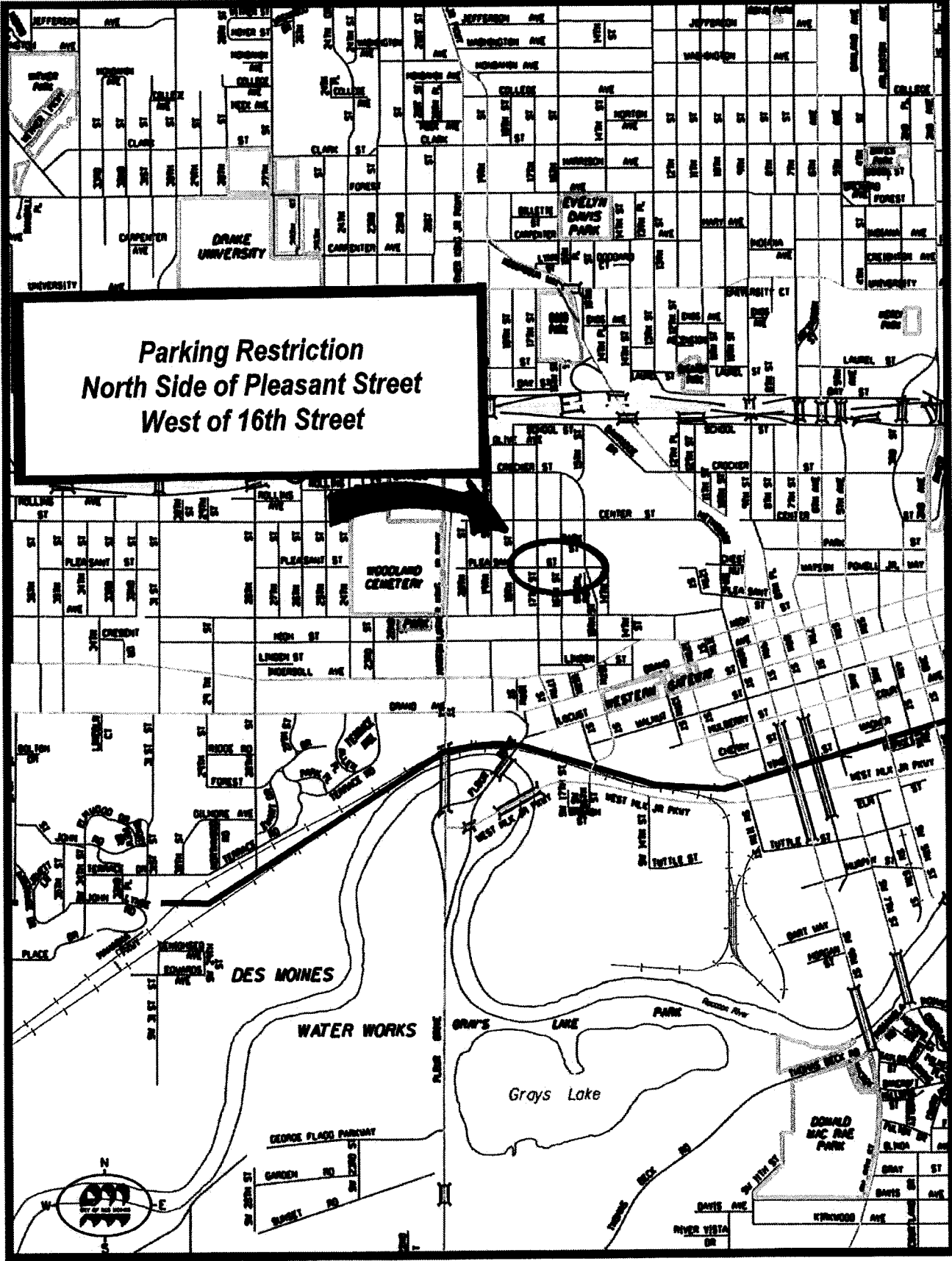
