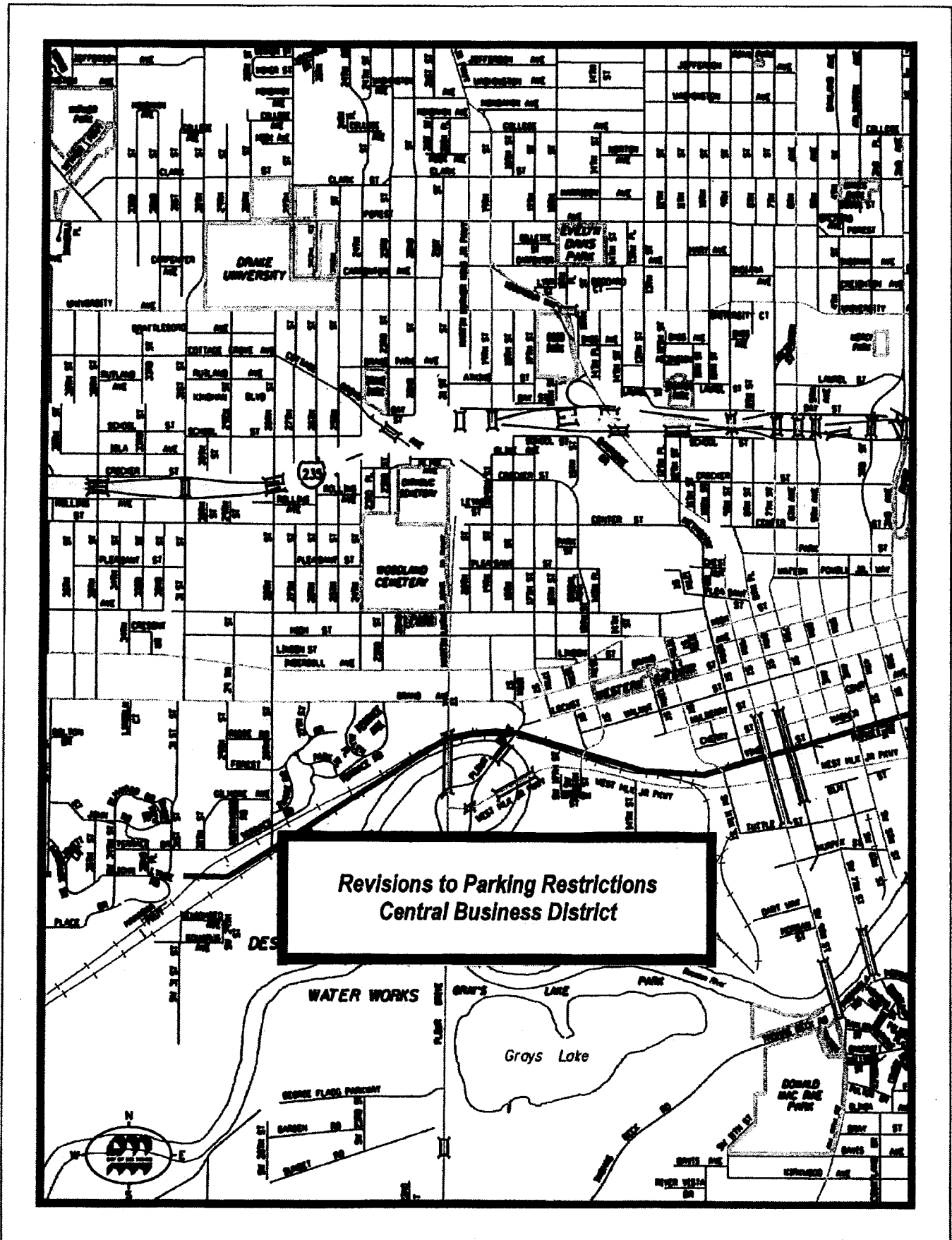

Be It Ordained by the City Council of the City of Des Moines, Iowa:

AGENDA HEADING:

Amending Chapter 114 of the Municipal Code Regarding Traffic Regulation Changes as follows:

Revisions to Parking Restrictions—Central Business District.

SYNOPSIS:

Recommend approval of the staff recommendations, including first reading of the Ordinance regarding the traffic regulation changes.

FISCAL IMPACT:

Amount: Minor costs for signing modifications.

Funding Source: 2013-2014 Operating Budget, Page 80, Engineering Department, Traffic & Transportation—Sign Installation and Maintenance, EG062080.

ADDITIONAL INFORMATION:

Since the reconstruction of the 15th/16th Street connection to West Martin Luther King Jr. Parkway, the traffic patterns on the west end of the Central Business District have changed considerably. There has been renovation completed (or is currently ongoing) in the Crane Building, Mitchell Transmission Building, Fitch Building, and Mulberry Street has been extended to 15th Street with the construction of a new Fire Station #1 and new homeless shelter. The remodel of 1514 Walnut Street established a new restaurant, Exile Brewing Company. All of these activities have created distinct changes in on-street parking patterns, increasing the demand for on-street parking (long-term and short-term) in this area. In coordination with Robert Tursi (Exile Brewing Company), Greg Scheidemann (Fitch Studio Building), Angela Heldt (Crane Artist's Lofts), and the Des Moines Fire Chief John TeKippe, the Traffic & Transportation Division has reviewed the on-street parking needs in the area of Mulberry Street (13th Street to 15th Street), Walnut Street (15th to 16th Streets), and 15th & 16th Streets (West Martin Luther King Jr. Parkway to Locust Street).

This ordinance change requests:

1. Adds new long-term parking meters on the north side of Mulberry Street, from Falcon Drive to approximately 300 feet east.
2. Adds new long-term parking meters on 16th Street, north of Walnut Street.
3. Adds new short-term parking meters on 16th Street, south of Walnut Street.
4. Adds new short-term parking meters on 15th Street, between Walnut and Mulberry Streets.

5. Adds new long-term parking meters on Falcon Drive, north of Mulberry Street.
6. Removed the 7:00 a.m. to 9:00 a.m. rush hour parking restriction on 15th Street, for south bound traffic, between Locust Street and Walnut Street.
7. Changes two (2) existing commercial loading zones to 24-hour restricted loading zones.
8. Removes the loading zone on Walnut Street, at 16th Street.
9. Installs several no parking restrictions on 15th Street, between West M L King Jr Parkway and Walnut Street to meet sight distance guidelines for entering traffic at intersections.
10. Changes some of the existing short-term parking meters on Mulberry Street, east of Falcon Drive, to long-term parking meters.
