AUTHORIZING ACQUISITION OF 1712 8TH STREET THROUGH DONATION FROM HALF MOON HOLDINGS, LC

WHEREAS, the property at 1712 8th Street (hereinafter the "Property") is a vacant parcel in the River Bend Neighborhood situated between two other vacant parcels owned by the River Bend Neighborhood Association, and is suitable for redevelopment either as a single-family dwelling or as part of a low-density multi-family project; and,

WHEREAS, Half Moon Holdings, L.C., acquired the Property by tax deed on November 11, 2012, through foreclosure of a Tax Sale Certificate purchased at the 2009 Polk County Tax Sale; and,

WHEREAS, Half Moon Holdings, L.C., has offered to donate the Property to the City at no cost, subject to the City's acknowledgment that the assessed value of the Property as established by the Polk County Assessor is \$6,400.00; and

WHEREAS, the Property is subject to outstanding levies for back taxes totaling approximately \$11,469, which the County Board of Supervisors will consider waiving if the property becomes publicly owned; and

WHEREAS, the Property is subject to the special assessments levied by the following entities, which the City staff will request be released upon the City taking ownership of the Property:

City of Des Moines	\$8,702.22
Des Moines Water Works	\$1,862.57
Polk County Weed Commissioner	\$631.50
Total all Special Assessments	\$11,196.29

WHEREAS, it would facilitate redevelopment of the Property if the City were to take ownership of the Property to clear the back taxes, special assessments and costs levied against the Property; and

WHEREAS, the City staff will work with the River Bend Neighborhood Association to find an appropriate developer and development for the Property;

NOW THEREFORE, BE IT RESOLVED, by the City Council of the City of Des Moines, Iowa, as follows:

1. That the donation of the Property from HALF MOON HOLDINGS, L.C., is hereby approved and accepted, subject to the City Legal Department approving the form of the deed and confirming that the City is receiving marketable title to the Property subject only to the outstanding levies for taxes and special assessments which the City will seek to have released.
