WHEREAS, by separate action of this date, the City Council passed Ordinance No. constituting an ordinance amending the franchise heretofore granted to MidAmerican Energy Company for the production, distribution, transmission and sale of electric energy and amending the franchise heretofore granted to MidAmerican Energy Company for the production, distribution, transmission and sale of gas to temporarily increase the franchise fee to be used solely toward payment of the *Kragnes v. City of Des Moines* judgment; and

WHEREAS, Iowa Code Section 364.2(4)(f) requires that such ordinance providing for the temporary increase to the franchise fee greater than five percent (5%) shall not become effective unless approved at an election by a majority vote; and

WHEREAS, in accordance with Iowa Code Section 364.2(4)(f) the City Council must submit the ordinance proposal at a special election held on a date specified in Iowa Code Section 39.2(4)(b) which provides that the next available date for a special election on a public measure is Tuesday, March 4, 2014.

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Des Moines, Iowa that a special election is hereby called on the public measure to consider approval of Ordinance No. _______, an ordinance amending the franchise heretofore granted to MidAmerican Energy Company for the production, distribution, transmission and sale of electric energy and amending the franchise heretofore granted to MidAmerican Energy Company for the production, distribution, transmission and sale of gas to temporarily increase the franchise fee to be used solely toward payment of the *Kragnes v. City of Des Moines* judgment, to be held on March 4, 2014.
