APPROVING COMPLETION AND ACCEPTANCE OF THE PRIVATE CONSTRUCTION CONTRACT FOR PAVING IMPROVEMENTS, 5830 S.E. 14TH STREET, BETWEEN HENNING CONSTRUCTION CO., INC. AND KUM & GO, L.C.

Krause, CEO, 6400 Westown Parkway, West Des Moines, IA, 50266 - as Owner, for construction of Paving Improvements described as installation of a deceleration lane in southbound S.E. 14th Street north of E. Diehl Avenue, Des Moines, Iowa, in accordance with the contract documents including Plan File Nos. 538-036/040, and granted permission to the parties of said contract to construct these improvements in accordance with the contract documents and subject to the inspection and approval of the Des Moines City Engineer.


