**Approval of Memorandum of Agreement Between the City and  
Des Moines Area Regional Transit Authority (DART) to Establish  
Policies and Procedures Relating to the Operation of the  
Center Street Park and Ride Facility**

WHEREAS, by Roll Call No. 97-1549 of April 28, 1997, the City Council of the City of Des Moines approved a 28E Intergovernmental Agreement between the City and Des Moines Area Regional Transit Authority (DART) f/k/a Des Moines Metropolitan Transit Authority, wherein the City became a sub-grantee to certain Federal Transit Administration (FTA) grants for the construction, ownership, and operation of the Center Street Park and Ride Facility; and,

WHEREAS, in May 2012, the FTA completed a tri-annual review of DART operations and determined that DART was deficient in its oversight of the Center Street Park and Ride Facility; and,

WHEREAS, in order to resolve the findings in the FTA procedures review draft report, the City and DART have prepared a Memorandum of Agreement that has been approved by FTA to establish policies and procedures relating to the operation of the Center Street Park and Ride Facility; and

NOW THEREFORE, BE IT RESOLVED, by the City Council of the City of Des Moines, Iowa, that the Memorandum of Agreement between the City and Des Moines Area Regional Transit Authority to establish policies and procedures relating to the operation of Center Street Park and Ride Facility is hereby approved and the Mayor is authorized and directed to sign the Memorandum of Agreement on behalf of the City, and the City Clerk is directed to attest to the Mayor's signature; and
