**RESOLUTION SCHEDULING PUBLIC HEARING ON THE PROPOSED
RENAMING OF THE SEGMENT OF THE SOUTHWEST CONNECTOR LOCATED
WEST OF IOWA HIGHWAY 28 TO VETERANS PARKWAY**

WHEREAS, the City staff have requested that the segment of the Southwest Connector extending west from Iowa Highway 28 to the west City boundary be renamed "Veterans Parkway" to better coordinate emergency response services between jurisdictions and to eliminate the confusion created by one block of street having two names; and,

WHEREAS, the City Plan and Zoning Commission has advised that at a public hearing held on February 6, 2014, its members voted 9-0 in support of a motion to recommend **APPROVAL** of the proposed street renaming.

NOW THEREFORE, BE IT RESOLVED, by the City Council of the City of Des Moines, Iowa as follows:

1. That the City Council consider the proposal to rename the segment of the Southwest Connector west of Iowa Highway 28 to "Veterans Parkway" at a public hearing to be held in the Council Chambers at 5:00 p.m. on March 10, 2014, at which time the City Council will hear both those who oppose and those who favor the proposal.

2. The City Clerk is hereby authorized and directed to cause notice of said proposal in the accompanying form to be given by publication once, not less than four (4) days and not more than twenty (20) days before the date of hearing.

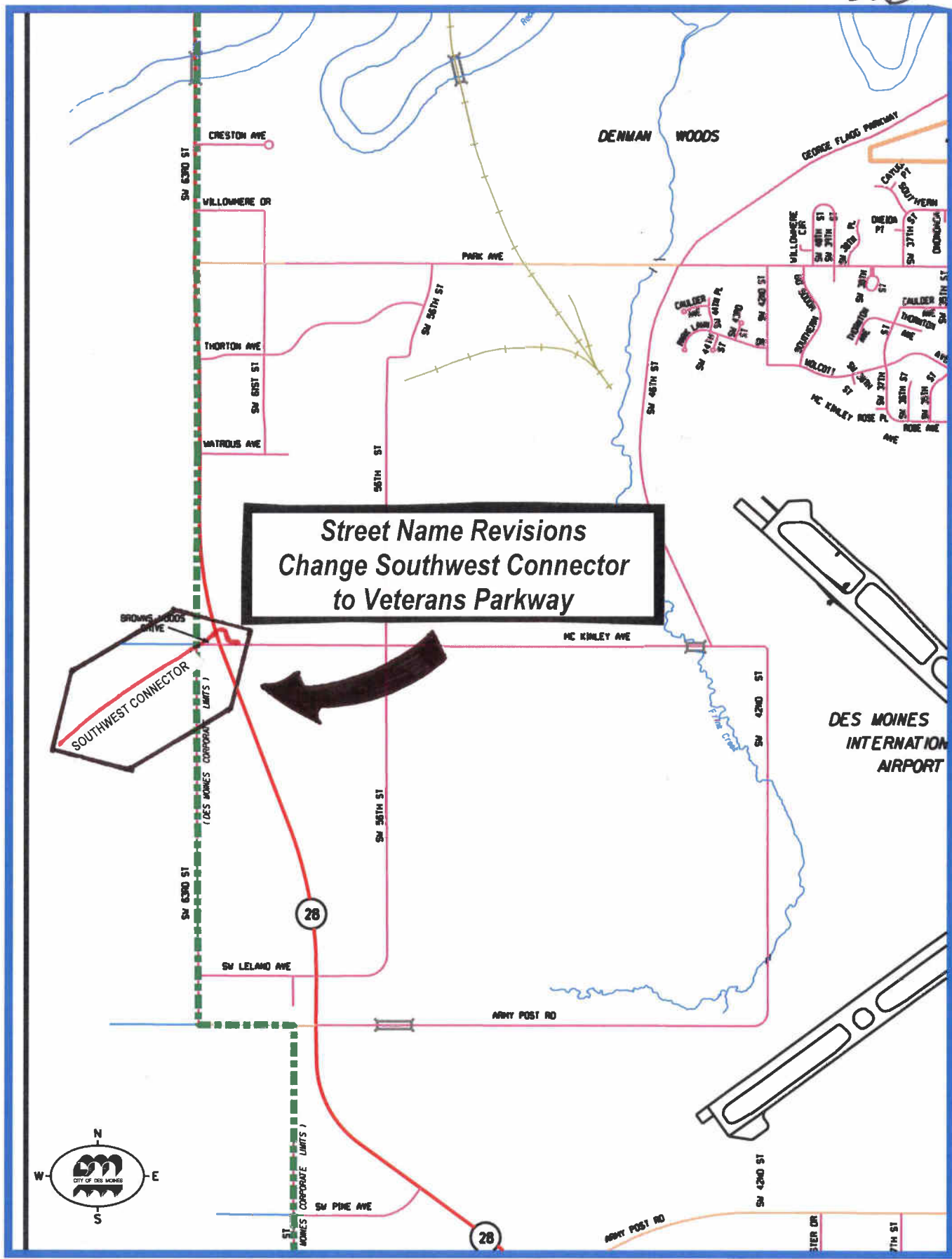

STAFF RECOMMENDATION TO THE P&Z COMMISSION

Staff recommends renaming of the subject segment of Southwest Connector (between Western Corporate Limit and Iowa Highway 28) to Veterans Parkway.

STAFF REPORT TO THE PLANNING COMMISSION

I. GENERAL INFORMATION

1. **Purpose of Request:** The City is requesting to rename the Southwest Connector (between Western Corporate Limit and Iowa Highway 28) to "Veterans Parkway". The renaming will allow the street's name to be consistent within both Des Moines and West Des Moines.
2. **Size of Site:** Approximately 285 lineal feet.
3. **Existing Land Use (site):** Developed segment of street that connects Veterans Parkway within West Des Moines to Iowa Highway 28 within Des Moines.
4. **General Neighborhood/Area Land Uses:** The subject street segment is located to the west of Iowa Highway 28 in an area that transitions from Business Park use to the north to low-density residential uses to the south.
5. **Adjacent Land Use and Zoning:**

North – "C-2": Use is a vacant parcel owned by the City of West Des Moines.

South – "C-2". Uses include vacant parcels owned by City of Des Moines Real Estate, City of Des Moines and State of Iowa.

East – "C-2". Uses include Highway 28 and vacant parcels owned by the City of Des Moines.

West – "RM" (Residential-Medium Density, West Des Moines designation). The west edge of the subject segment adjoins Veterans Parkway within the City of West Des Moines.

6. **Applicable Recognized Neighborhood(s):** The subject property is located in the Southwestern Hills Neighborhood. This neighborhood association was notified of the public hearing by mailing of the Preliminary Agenda on December 30, 2013. Separate notifications of the hearing for this specific item were mailed on January 6, 2014 to the primary titleholder on file with the Polk County Assessor for each property adjoining the street. Additionally, the Southwestern Hills Neighborhood was notified of the public hearing by mailing of the Final Agenda on January 10, 2014.

All agendas and notices are mailed to the primary contact(s) designated by the recognized neighborhood association to the City of Des Moines Neighborhood Development Division. The Southwestern Hills Neighborhood mailings were sent to George Davis, 3124 Southwest 29th Street, Des Moines, IA 50321.

7. **Relevant Zoning History:** NA.

8. Applicable Regulations: In accordance with Chapter 82 Section 44 of the City Code, the Commission reviews all proposed street name changes to determine whether they will have any impact on the City Comprehensive Plan. The recommendation of the Commission is forwarded to the City Council.

II. ADDITIONAL APPLICABLE INFORMATION

1. Traffic/Street System: The renaming of Southwest Connector will have no impact on traffic. There are no assigned addresses off the subject roadway segment and the renaming will have no impact on postal delivery to adjoining properties. There would be a benefit to wayfinding of the street from Iowa Highway 28 that is consistent between jurisdictions.

SUMMARY OF DISCUSSION

There was no discussion.

CHAIRPERSON OPENED THE PUBLIC HEARING

There was no one to speak in favor or in opposition of the applicant's request.

COMMISSION ACTION:

Ted Irvine moved staff recommendation to approve the renaming of the subject segment of Southwest Connector (between Western Corporate Limit and Iowa Highway 28) to Veterans Parkway.
