AN ORDINANCE to amend the Municipal Code of the City of Des Moines, Iowa, 2000, adopted by Ordinance No. 13,827, passed June 5, 2000, as heretofore amended, is hereby amended by amending Section 114-319.03(52) and by adding and enacting new Section 114-2287.05, relating to traffic and vehicle regulations.

Be It Ordained by the City Council of the City of Des Moines, Iowa:

Section 1. That the Municipal Code of the City of Des Moines, Iowa, 2000, adopted by Ordinance No. 13,827, passed June 5, 2000, as heretofore amended, is hereby amended by amending Section 114-319.03(52) and by adding and enacting new Section 114-2287.05, relating to traffic and vehicle regulations, as follows:

**Sec. 114-319.03. Location of four-way stop intersections.**

The following intersections are designated as four-way stop intersections. Stop signs shall be installed and maintained at the following intersections, and the driver of a vehicle approaching these intersections from all directions shall stop in accordance with this chapter before entering the intersections:

**Sec. 114-2287.05. Meredith Drive.**

Meredith Drive, from the west line of Beaver Avenue to the east line of 50<sup>th</sup> Street, stop.  
Meredith Drive, from the west line of 50<sup>th</sup> Street to the east line of Merle Hay Road, stop.

Section 2. This ordinance shall be in full force and effect from and after its passage and publication as provided by law.
