HEARING AND ADOPTION OF THE RECOMMENDED CAPITAL IMPROVEMENT PROGRAM FOR FISCAL YEARS 2014-2015 THROUGH 2019-2020

WHEREAS, the City Manager has submitted a recommended Capital Improvement Program (CIP) which includes the Capital Improvement Plan for fiscal years 2014-2015 through 2019-2020 and includes the Capital Improvement Budgets for fiscal year 2013-2014, as amended, and fiscal year 2014-2015; and

WHEREAS, Section 384.15(3), Code of Iowa, requires a public hearing on the recommended Capital Improvement Program prior to its adoption; and

WHEREAS, on February 24, 2014 by Roll Call No. 14-0290 the City Council set the public hearing to consider the City's recommended Capital Improvement Program for the fiscal years 2014-2015 through 2019-2020 for March 10, 2014 at 5:00 p.m. in the Council Chambers of City Hall and public notice of such hearing has been published as provided by law in the Des Moines Register on February 27, 2014; and

WHEREAS, those residents and taxpayers of the City interested in the City's recommended Capital Improvement Program for the fiscal years 2014-2015 through 2019-2020, have been given an opportunity to present to the City Council objections to any part of the Plan and arguments in favor of any part of the Plan at this public hearing.

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Des Moines, Iowa, that:

1. Upon due consideration of all views and comments presented by City residents and taxpayers, the public hearing on the City of Des Moines recommended Capital Improvement Program for the fiscal years 2014-2015 through 2019-2020 is hereby closed.
2. The City of Des Moines recommended Capital Improvement Program for the fiscal years 2014-2015 through 2019-2020 on file in the Office of the City Clerk is hereby approved and adopted.
