SET HEARING FOR VACATION AND CONVEYANCE OF THE REMAINING SEGMENT OF EAST/WEST ALLEY RIGHT-OF-WAY ADJOINING 306 EAST 3RD STREET TO 201 EAST LOCUST, LLC, FOR \$31,000

WHEREAS, on March 9, 2009, by Roll Call No. 09-379, the City Council received a recommendation from the City Plan and Zoning Commission that a segment of the east/west alley right-of-way between East Locust Street and East Walnut Street, running 88 feet west of East 3rd Street ("City Right-of-Way"), be vacated subject to reservation of easement for existing utilities; and

WHEREAS, 201 East Locust, LLC, is the owner of real property abutting the City Right-of-Way and has offered to the City of Des Moines the purchase price of \$31,000 for the vacation and purchase the Right-of-Way for incorporation into the adjoining property, which price reflects the fair market value of the City Right-of-Way as determined by the City's Real Estate Division; and

WHEREAS, there is no known current or anticipated public benefit or need for the City Right-of-Way that is proposed to be vacated, and the City will not be inconvenienced by the proposed vacation and sale of the City Right-of-Way.

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Des Moines, Iowa, as follows:

1. That the City Council of the City of Des Moines shall consider adoption of an ordinance permanently vacating a segment of the east/west alley right-of way between East Locust Street and East Walnut Street, running 88 feet west of East 3rd Street, legally described as follows:

EXCEPT THE WEST 44 FEET - ALL THAT PART OF THE EAST/WEST ALLEY RIGHT OF WAY LYING SOUTH OF AND ADJOINING LOT 6 IN BLOCK G, SCOTT & DEAN'S ADDITION, AN OFFICIAL PLAT; ALL NOW INCLUDED IN AND FORMING A PART OF THE CITY OF DES MOINES, POLK COUNTY, IOWA, AND CONTAINING APROXIMATELY 1408 SQUARE FEET.

2. That if the City Council decides to vacate the above described right-of-way, the City of Des Moines proposes to sell such right-of-way, as legally described below, to 201 East Locust, LLC for \$31,000:

EXCEPT THE WEST 44 FEET - ALL THAT PART OF THE VACATED EAST/WEST ALLEY RIGHT OF WAY LYING SOUTH OF AND ADJOINING LOT 6 IN BLOCK G, SCOTT & DEAN'S ADDITION, AN OFFICIAL PLAT; ALL NOW INCLUDED IN AND FORMING A PART OF THE CITY OF DES MOINES, POLK COUNTY, IOWA, AND CONTAINING APROXIMATELY 1408 SQUARE FEET.
