ORDINANCE NO.	

AN ORDINANCE vacating Allen Park, located at 504 SE 6th Street, Des Moines, Iowa.

WHEREAS, all prior requirements of law pertaining to the vacation of parkland have been fully observed; and

WHEREAS, it is desirable that the parkland herein described be vacated;

NOW, THEREFORE, BE IT ORDAINED by the City Council of the City of Des Moines, Iowa:

Sec. 1. That Allen Park, located at 504 SE 6th Street, Des Moines, Iowa, more specifically described as follows, be and is hereby vacated:

LOTS 6, 7, 8, 9 AND 10, BLOCK 46 TOWN OF DE MOINE, AN OFFICIAL PLAT, ALL NOW INCLUDED IN AND FORMING A PART OF THE CITY OF DES MOINES, POLK COUNTY, IOWA.

- Sec. 2. The City of Des Moines hereby reserves an easement upon the property described above for the continued use and maintenance of any utilities now in place, with the right of entry for servicing same.
