 - (A) 1524 Clark Street, building structure, Titleholder: Charles Stuewe
 - 07/30/2013 The structure was inspected and found to be a public nuisance.
 - 09/21/2013 The Public Nuisance Notice was served on Titleholder Charles Stuewe
 - 04/02/2014 The structure was re-inspected and found to remain a public nuisance. Photos were taken at this time.
 - 04/02/2014 The inspector reports no permits have been requested and no visible progress toward abatement
 - (B) **3510 Cottage Grove Avenue**, building structure, Titleholders: Rick A. Lee and Charlotte A. Lee; Mortgage Holder: Iowa State Bank
