

Re: Report to Council

Pursuant to the authority and direction of Council authorizing the City Attorney to settle claims, lawsuits and workers compensation actions for a total sum not to exceed \$5,000, I submit to Council the following summary report of settlements made:

JAY HALL \$596.46 for property damage due to automobile accident with plow driver on December 22, 2013; TRAVELERS PROPERTY AND CASUALTY COMPANY, \$4,403.54 for the collision deductible.

TERRY BROOKS \$167.20 for property damage due to City snow plow striking Claimant's vehicle on December 30, 2013.

ERICA DAVIS \$125.61 for property damage due to City snow plow striking Claimant's vehicle on December 8, 2013.

GLENN'S REEL & ROD REPAIR \$125.00 for property damage due to snow plow allegedly striking Claimant's downspout and metal siding on or about December 9, 2013.

CHARLES B. AHERN \$500.00 for Claimant's auto insurance deductible due to an auto accident with a City salt truck occurring on December 20, 2013.

CARROLL DEZWARTE \$1,401.77 for property damage to Claimant's parked truck by snow plow on December 22, 2013.

LEON FOSTER \$30.00 for damage to Claimant's mailbox by snow plow on December 30, 2013.

TYRAY GUNN \$883.97 for property damaged to Claimant's parked truck by snow plow on December 22, 2013.

DES MOINES PUBLIC SCHOOLS \$123.44 for damage caused by a City snow plow to side mirror on Claimant's bus #508 on December 20, 2013.

MICHELE GUADAGNOLI \$379.42 for damage to Claimant's vehicle due to auto accident with a snow plow occurring on December 22, 2013.

TMC AUTO BODY \$228.50 to pay towing and storage charges for Claimant Jason Krull's vehicle due to auto damaged caused by City snow plow in an accident occurring on January 17, 2014.

LEON and SHANTELE MELTON \$500.00 for settlement of personal injury claim due to an auto accident occurring on January 16, 2014.

ENTERPRISE RENT-A-CAR \$433.98 for car rental fees for Claimant Raymond Long due to an automobile accident with police officer occurring on December 27, 2013; TMC AUTO BODY, \$4,229.60 for repairs to automobile.

GEORGE BUCKINGHAM, \$30.00 for damage to mailbox that was struck by snow plow on February 5, 2014.

SCOTTY'S BODY SHOP, INC., \$2,792.90 for repairs to Claimant Joshua Towns' vehicle that was legally parked and struck by a snow plow on February 5, 2014.


HOLLY TOELLE, \$242.00 for property damage caused as a result of roots in the City sewer on January 20, 2014.

TERESA VAN DE BOE, \$139.87 for sewer service due to debris blocking the City main on January 31, 2014.

ENTERPRISE RENT-A-CAR, \$435.22 for car rental fees for Claimant Joshua Towns as the result of an automobile accident with snow plow occurring on February 4, 2014.
