HOLD HEARING FOR VACATION OF VARIOUS STREET AND ALLEY RIGHTS-OF-WAY BETWEEN SE 2ND STREET AND SE 6TH STREET AND BETWEEN SHAW STREET AND THE DES MOINES RIVER FOR THE PURPOSE OF DEDICATING A PORTION OF SUCH RIGHT-OF-WAY AND OTHER ADJOINING CITY-OWNED PROPERTY AS PARKLAND TO REPLACE ALLEN PARK

WHEREAS, the Des Moines City Council initiated a request for vacation of the following City-owned right-of-way for the purpose of dedicating a portion of such right-of-way and other adjoining City-owned property as parkland for the relocation of Allen Park: Maury Street from SE 6th Street to Des Moines River; Vale Street from SE 6th Street to Des Moines River; north/south alley in Block 66, Town of De Moine; SE 5th Street from Maury Street to Des Moines River; north/south alley in Block 58, Town of De Moine; SE 5th Street from Maury Street to Shaw Street; north/south alley in Block 57, Town of De Moine; Shaw Street from SE 2nd Street to east side of the north/south alley in Block 57, Town of De Moine; SE 4th Street and SE 2nd Street from Shaw Street to Des Moines River; and

WHEREAS, on April 21, 2014, by Roll Call No. 14-0613, the City Council of the City of Des Moines received and filed a recommendation from the City Plan and Zoning Commission to approve the proposal to vacate the right-of-way identified above; and

WHEREAS, there is no known current or future public need or benefit for the right-of-way proposed to be vacated and the City will not be inconvenienced by the vacation of said right-of-way, subject to reservation of easements for any existing utilities currently located within the right-of-way; and

WHEREAS, on May 5, 2014, by Roll Call No. 14-0688, it was duly resolved by the City Council that the proposed vacation of such right-of-way be set down for hearing on May 19, 2014, at 5:00 p.m., in the Council Chamber; and

WHEREAS, due notice of said proposal to vacate public right-of-way was given as provided by law, setting forth the time and place for hearing on said proposal; and

WHEREAS, in accordance with said notice, those interested in said proposed vacation, both for and against, have been given an opportunity to be heard with respect thereto and have presented their views to the City Council.

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Des Moines, Iowa:

- 1. Upon due consideration of the facts and statements of interested persons, any objections to said proposed vacation of public right-of-way, as described below, are hereby overruled and the hearing is closed.
- 2. There is no public need for or benefit from the right-of-way proposed to be vacated, and the City would not be inconvenienced by reason of the vacation of Maury Street from SE 6th Street to Des Moines River; Vale Street from SE 6th Street to Des Moines River; north/south alley in Block 66, Town of De
