PUBLIC HEARING, APPROVING PLANS, SPECIFICATIONS, FORM OF CONTRACT DOCUMENTS, AND ENGINEER'S ESTIMATE ON FIRE DEPARTMENT ADMINISTRATION PARKING LOT; RECEIVE AND FILE BIDS; AND DESIGNATION OF LOWEST RESPONSIVE, RESPONSIBLE BIDDER AS P. G. CONSTRUCTION INC., KEITH PURDY, PRESIDENT, \$62,608.74

WHEREAS, on April 7, 2014, under Roll Call No. 14-0523, plans, specifications, form of contract documents, and Engineer's estimate of construction cost were filed with the City Clerk, for the construction of the following improvement:

Fire Department Administration Parking Lot, 04-2014-001

The improvement includes construction of a PCC parking lot, detention basin modifications, site restoration, and other incidental items; all in accordance with the contract documents, including Plan File Nos. 557-143/147, located at the City of Des Moines Fire Department Administration Facility, 2715 Dean Avenue, Des Moines, Iowa

WHEREAS, notice of the hearing on the plans, specifications, form of contract documents, and Engineer's estimate of construction cost was published as required by law.

WHEREAS, the date of the public hearing on said plans, specifications, form of contract documents, and Engineer's estimate of construction cost for said improvement was set for May 5, 2014 in the City Council Chambers of City Hall; and

WHEREAS, on May 5, 2014, by Roll Call No. 14-0731, the City Council continued the public hearing until May 19, 2014 at 5:00 p.m. in the City Council Chambers at City Hall.


BE IT FURTHER RESOLVED: That the bid security of the unsuccessful bidders be and is hereby authorized and directed to be returned.
