Pursuant to the provisions of the Amended and Restated Agreement for the Des Moines Regional Transit Authority ("DART"), the term of office of your DART Commissioner ~~Joann Muldoon~~ will terminate on the 30th day of June, 2014. DART's Amended and Restated Agreement provides that the Mayors of each DART member city which is located in whole or in part in the Iowa House District No. 34 or in Iowa House District No. 35 (i.e., Des Moines) shall constitute a Selection Committee to jointly meet and elect one person to serve a four-year term as Commissioner and one person to serve a four-year term as an Alternate.
