APPROVAL OF RULES FOR PRINCIPAL RIVERWALK PARK AND MULTI-USE RECREATIONAL TRAIL

WHEREAS, the Park and Recreation Board is an advisory board to the Des Moines City Council; and

WHEREAS, pursuant to Section 74-26(a) of the Municipal Code of the City of Des Moines the Park and Recreation Board may prescribe necessary rules and regulations for the conduct, supervision and control of City playgrounds, recreation centers and special facilities, which rules and regulations must be reported to and approved by the City Council in order to be put into effect; and

WHEREAS, at its meeting on March 25, 2014, the Park and Recreation Board voted unanimously to approve a Rule prohibiting skateboards, bicycles, in-line skates or similar recreational equipment on park furniture, railings, concrete edges, and art/sculpture pieces at Principal Riverwalk Park, a copy of the complete Principal Riverwalk Rules, which also includes references to other conduct in the park prohibited pursuant to Chapter 74 of the Des Moines Municipal Code, are attached hereto.

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Des Moines, Iowa that the attached Rules for Principal Riverwalk Park and Multi-Use Recreational Trail are hereby approved and take effect immediately.

Principal Riverwalk Rules



- Hours are 6:00 AM to 2:00 AM (74-101)
- Sales within the park by permit only (74-113)
- Alcohol by permit only (74-92)
- No glass containers (74-96)
- Dogs must be on a leash and under control, Service Dogs must be under control (74-100)
- Pick up and properly dispose of pet waste (18-6)
- Wading or swimming in Des Moines River or water features is not allowed (74-112)
- Damage, injury, or removal to/of any plant or animal life is prohibited (74-93)
- No weapons may be discharged in the park (74-95)
- No fireworks may be discharged in the park without a permit (74-95)
- Do not litter; use waste containers (74-96)
- Unauthorized signs will be removed (74-103)
- Commercial photography by a permit only (74-114)
- No motorized vehicles on Riverwalk, except motorized mobility devices (74-115)
- Skateboards, bicycles, in-line skates or similar recreational equipment on park furniture, railings, concrete edges, art/sculpture pieces is prohibited (74-99)
- No camping (74-101.5)
