WHEREAS, on April 26, 2010, by Roll Call No. 10-617, the City Council approved a one year renewal of the agreement, on May 9, 2011, by Roll Call No. 11-0801, the City Council approved a one year renewal of the agreement, and on May 7, 2012 the City Council approved a one year renewal of the agreement, which expired on April 30, 2013; and

WHEREAS, on June 10, 2014 by Roll Call No. 13-0912, the City Council approved a new agreement with Holland & Knight, LLP to provide professional federal government affairs services with an initial term of one year, with up to three one year renewal options upon mutual consent of both parties, in the amount of \$8,000 per month for the initial year and first two renewal years and \$8,500 per year for the third renewal year, plus travel expenses: and

WHEREAS, the City and Holland & Knight desire to renew the agreement until April, 30, 2015.
