AN ORDINANCE to amend the Municipal Code of the City of Des Moines, Iowa, 2000, adopted by Ordinance No. 13,827, passed June 5, 2000, as heretofore amended, by amending Sections 114-2579, 114-2595, 114-2622, 114-3115, 114-3206, 114-4076 and 114-4081, relating to traffic and vehicle regulations.

Be It Ordained by the City Council of the City of Des Moines, Iowa:

Section 1. That the Municipal Code of the City of Des Moines, Iowa, 2000, adopted by Ordinance No. 13,827, passed June 5, 2000, as heretofore amended, is hereby amended by amending Sections 114-2579, 114-2595, 114-2622, 114-3115, 114-3206, 114-4076 and 114-4081, relating to traffic and vehicle regulations, as follows:

**Sec. 114-2579. East First Street--East Vine Street to East Court Avenue.**

East First Street, on the west side, from East Vine Street to a point 243 feet south of East Court Avenue, no parking any time.

East First Street, on the east side, from a point 45 feet south of East Court Avenue to a point 50 feet south thereof, is designated as handicapped parking spaces and are subject to the same prohibition as is found in subsection 114-616(a) of this chapter.

East First Street, on the west side, from East Court Avenue to a point 55 feet south thereof, no parking any time.

East First Street, on the east side, from East Court Avenue to a point ~~45~~ 20 feet south thereof, no parking any time.

East First Street, on the east side, from a point ~~65~~ 95 feet south of East Court Avenue to a point ~~135~~ 295 feet south thereof, reserved for official police vehicles.

East First Street, on the east side, from a point 390 feet south of East Court Avenue to a point 50 feet south thereof, commercial loading zone.

~~East First Street, on the east side, from a point 200 feet south of East Court Avenue to a point 50 feet south thereof, no parking any time.~~

**Sec. 114-2595. East Second Street--East Vine Street to East Court Avenue.**

East Second Street, on the west side, from East Court Avenue to a point ~~110~~ 135 feet south thereof, no parking any time.

East Second Street, on the east side, from East Court Avenue to a point 200 feet south thereof, no parking any time.

East Second Street, on the west side, from a point 135 feet south of East Court Avenue to a point 25 feet south thereof, parking reserved for official police vehicles only.

East Second Street, on the west side, from a point 160 feet south of East Court Avenue to a point 85 feet south thereof, no parking any time.

East Second Street, on the west side, from a point 245 feet south of East Court Avenue to a point 40 feet south thereof, parking reserved for official police vehicles only.

East Second Street, on the west side, from a point 285 feet south of East Court Avenue to Vine Street, no parking any time.

**Sec. 114-2622. East Fourth Street--East Vine Street to Maple Street.**

East Fourth Street, on the east side, from East Vine Street to East Court Avenue, no parking any time.

East Fourth Street, on the west side, from East Walnut Street to a point 220 feet south thereof, no parking any time.

East Fourth Street, on the west side, from East Walnut Street to a point 50 feet north thereof, no parking any time.

East Fourth Street, on both sides, from a point 50 feet north of East Grand Avenue to a point 50 feet south thereof, no parking any time.

East Fourth Street, on both sides, from a point 50 feet south of Des Moines Street to Des Moines Street, no parking any time.

East Fourth Street, on the east side, from Des Moines Street to a point 50 feet north thereof, no parking any time.

East Fourth Street, on the east side, from a point 200 feet north of Des Moines Street to a point 90 feet north thereof, no parking any time.

East Fourth Street, on the west side, from Des Moines Street to Maple Street, no parking any time.

**Sec. 114-3115. East Court Avenue--Water Street to East Second Street.**

East Court Avenue, on the south side, from East First Street to a point 80 feet west thereof, no parking any time.

East Court Avenue, on the north side, from East First Street to a point 65 feet west thereof, no parking any time.

East Court Avenue, on the south side, from a point 80 feet west of East First Street to a point 60 feet west thereof, reserved for city of Des Moines municipal employee permit parking and are designated handicapped parking spaces, subject to the same prohibition as is found in subsection 114-616(a) of this chapter.

East Court Avenue, on the south side, from a point 140 feet west of East First Street to a point 235 feet west thereof, reserved for city of Des Moines municipal employee permit parking, 7:00 a.m. to 4:00 p.m., Monday through Friday.

East Court Avenue, on the north side, from a point 65 feet west of East First Street to a point 240 feet west thereof, reserved for city of Des Moines municipal employee permit parking, 7:00 a.m. to 4:00 p.m., Monday through Friday.

East Court Avenue, on the south side, from East First Street to a point ~~50~~ 35 feet east thereof, ~~west of East Second Street, reserved for official police vehicles~~ no parking any time.

East Court Avenue, on the south side, from a point 35 feet east of East First Street to a point 45 feet east thereof, loading zone, 20 minute limit.

East Court Avenue, on the south side of the street, from a point 80 feet east of East First Street to a point 50 feet west of East Second Street, back-in angle parking only, parking reserved for official police vehicles only.

East Court Avenue, on the north side, from a point 165 feet east of East First Street to a point 40 feet east thereof, loading zone.

East Court Avenue, on the south side, from East Second Street to a point 50 feet west thereof, no parking any time.

East Court Avenue, on the north side, from East First Street to a point 165 feet east thereof, no stopping or standing.

East Court Avenue, on the north side, from a point 205 feet east of East First Street to a point 75 feet west of East Second Street, no stopping or standing.

East Court Avenue, on the north side, from East Second Street to a point 75 feet west thereof, no parking any time.

**Sec. 114-3206. Forest Avenue--Twenty-third Street to Thirtieth Street.**

Forest Avenue, on the south side, from Twenty-third Street to Twenty-fourth Street, two-hour parking 9:00 a.m. to 4:00 p.m.

Forest Avenue, on the north side, from Twenty-fourth Street to Twenty-fifth Street, no parking 4:00 p.m. to 6:00 p.m.

Forest Avenue, on the north side, from Twenty-third Street to a point 60 feet west thereof, no parking any time.

Forest Avenue, on the north side, from a point 60 feet west of Twenty-third Street to a point 80 feet west thereof, no parking 4:00 p.m. to 6:00 p.m., Monday through Friday.

Forest Avenue, on the north side, from a point 130 feet west of Twenty-third Street to a point 140 feet west thereof, no parking 4:00 p.m. to 6:00 p.m., Monday through Friday.

Forest Avenue, on the north side, from a point 270 feet west of Twenty-third Street to a point 50 feet east of Twenty-fourth Street, no parking 4:00 p.m. to 6:00 p.m., Monday through Friday.

Forest Avenue, on the south side, from Twenty-third Street to a point 155 feet east of Twenty-seventh Street, no parking 7:00 a.m. to 9:00 a.m.

Forest Avenue, on the north side, from Twenty-fourth Street to a point 50 feet east thereof, no parking any time.

Forest Avenue, on the north side, from Twenty-fourth Street to Twenty-fifth Street, two-hour parking 9:00 a.m. to 4:00 p.m.

Forest Avenue, on the north side, from Twenty-fifth Street to a point 125 feet west thereof, no parking any time.

Forest Avenue, on the north side, from a point 125 feet west of Twenty-fifth Street to a point 100 feet west thereof, loading zone.

Forest Avenue, on the north side, from a point 225 feet west of Twenty-fifth Street to a point 225 feet east of Twenty-ninth Street, no parking any time.

Forest Avenue, on the south side, from Twenty-fifth Street to Twenty-seventh Street, no parking any time.

Forest Avenue, on the south side, from a point 130 feet west of Twenty-seventh Street to a point 190 feet west thereof, no parking 7:00 a.m. to 9:00 a.m.

Forest Avenue, on the south side, from Twenty-seventh Street to a point 130 feet west thereof, no parking any time.

Forest Avenue, on the south side, from a point 320 feet west of Twenty-seventh Street to a point 115 feet west thereof, passenger loading and unloading, ten minutes only.

Forest Avenue, on the north side, from a point 55 feet east of Twenty-ninth Street to a point 50 feet west of Twenty-ninth Street, no parking any time.

Forest Avenue, on the north side, from a point 50 feet west of Twenty-ninth Street to a point 145 feet east of Thirtieth Street, no parking 4:00 p.m. to 6:00 p.m.

Forest Avenue, on the north side, from Thirtieth Street to a point 145 feet east thereof, no parking any time.

Forest Avenue, on the south side, from a point 350 feet east of Thirtieth Street to a point 80 feet east thereof, commercial loading zone.

Forest Avenue, on the south side, from Thirtieth Street to a point 120 feet east thereof, no parking any time.

**Sec. 114-4076. East First Street--East Vine Street to East Court Avenue.**

East First Street, on the east side, from a point ~~19~~ 20 feet south of East Court Avenue to a point ~~64~~ 25 feet south thereof, parking meters E1-101, ~~E1-103 and E1-105~~ two-hour meters, 8:00 a.m. to 6:00 p.m., ~~are~~ is designated as handicapped parking spaces and ~~are~~ is subject to the same prohibition as is found in subsection 114-616(a) of this chapter.

~~East First Street, on the east side, from a point 83 feet south of East Court Avenue to a point 68 feet south thereof, 30-minute meters, first fifteen minutes free (must push button), 8:00 a.m. to 6:00 p.m.~~

~~East First Street, on the west side, from a point 55 feet south of East Court Avenue to a point 180 feet south thereof, two-hour meters, 8:00 a.m. to 6:00 p.m.~~

~~East First Street, on the east side from a point 151 feet south of East Court Avenue to a point 42 feet south thereof, two-hour meters, 8:00 a.m. to 6:00 p.m.~~

**Sec. 114-4081. East Fourth Street--East Walnut Street to Des Moines Street.**

East Fourth Street, on the west side, from a point 50 feet north of East Walnut Street to East Locust Street, four-hour meters, 8:00 a.m. to 6:00 p.m.

East Fourth Street, on the east side, from East Walnut Street to East Locust Street, ten-hour meters, 8:00 a.m. to 6:00 p.m.

East Fourth Street, on the east side, parking meter E4-322, ten-hour meter, is designated as a handicapped parking space and is subject to the same prohibition as is found in subsection 114-616(a) of this chapter.

East Fourth Street, on the west side, from East Locust Street to a point 50 feet south of East Grand Avenue, two-hour meters, 8:00 a.m. to 6:00 p.m.

East Fourth Street, on the east side, from East Locust Street to a point 140 feet north thereof, two-hour meters, 8:00 a.m. to 6:00 p.m.

East Fourth Street, on the west side, from a point fifty feet north of East Grand Avenue to a point 50 feet south of Des Moines Street, four-hour meters, 8:00 a.m. to 6:00 p.m.

East Fourth Street, on the east side, from a point fifty feet north of East Grand Avenue to a point 50 feet south of Des Moines Street, four-hour meters, 8:00 a.m. to 6:00 p.m.

Section 2. This ordinance shall be in full force and effect from and after its passage and publication as provided by law.






**Parking Restrictions on the West Side of E 4th Street at E Walnut Street**
