PUBLIC HEARING, APPROVING PLANS, SPECIFICATIONS, FORM OF CONTRACT DOCUMENTS, AND ENGINEER'S ESTIMATE ON 5TH & WALNUT PARKING GARAGE REPAIRS; RECEIVE AND FILE BIDS; AND DESIGNATION OF LOWEST RESPONSIVE, RESPONSIBLE BIDDER AS IOWA STATE CONTRACTORS, INC., JOSEPH CICHOWSKI, PRESIDENT, \$77,085.30

WHEREAS, on May 18, 2015, under Roll Call No. 15-0788, plans, specifications, form of contract documents, and Engineer's estimate of construction cost were filed with the City Clerk, for the construction of the following improvement:

5th & Walnut Parking Garage Repairs, 04-2015-007

The improvements include, concrete removal, foundation excavation, reinforcing steel, structural steel fabrication and installation, traffic control, and mobilization; all in accordance with the contract documents, located at the 5th and Walnut Parking Garage, 422 Walnut Street, Des Moines, Iowa

WHEREAS, notice of the hearing on the plans, specifications, form of contract documents, and Engineer's estimate of construction cost was published as required by law.

BE IT FURTHER RESOLVED: That the Des Moines City Engineer, as the Engineer, has determined that the lowest responsive, responsible bid for the construction of said improvement was submitted by Iowa State Contractors, Inc., Joseph Cichowski, President, 26 Greenbriar Ln, Ottumwa, IA, 52501 in the amount of \$77,085.30, and said bid be and the same is hereby accepted.


BE IT FURTHER RESOLVED: That the City Council hereby authorizes the necessary road closures for the Project.


