Be It Ordained by the City Council of the City of Des Moines, Iowa:

Section 1. That the Official Zoning Map of the City of Des Moines, Iowa, set forth in Section 134-277 of the Municipal Code of the City of Des Moines, Iowa, 2000, be and the same is hereby amended by rezoning and changing the district classification of certain property located in the vicinity of 3300 East 56<sup>th</sup> Street and at 3734, 3735, and 3768 East 55th Street, more fully described as follows, from the "A-1" Agricultural District to "PUD" Planned Unit Development classification:


Lots 2, 3, and 5 in FINI ACRES PLAT 2, an Official Plat in Polk County, Iowa.
